Chapter members, I hope everyone is doing well and in good health. April is here and we're starting to have some nice riding weather. Page 2 of the newsletter list our April birthday members and I wish all of you a happy birthday and hope you have many more.

Please mark **April 18th** on your calendar for the Chapter meeting and Tour at the Indiana War Memorial. We'll have a short Chapter meeting in the Pershing Auditorium followed by a guided tour or self tour of the facilities. The Indiana War Memorial has a lot of Indiana Military history that you won't see anywhere else.

An update on the Indiana Military Family Relief Fund (MFRF). SB316 had its third and final reading on March 30th and passed without amending the two provisions "Under Conditions Other Than Dishonorable" and 10% of the funds that IDVA can use for advertising. This means offenders could potentially have access to the MFRF funds. On page 3 of the newsletter, is an article that Roger Williams, the immediate past commander for AMVETS Department of Indiana wrote in the Ft. Wayne Newspaper that sums up SB316.

SB316 has some provisions that are long overdue and will open the door to a lot of Indiana Veterans in need that have Honorable discharges. it's unfortunate that the Indiana legislators allowed the standard for the MFRF fund to be lowered to less than Honorable. However, the Chapter can feel good about the funds from the POW/MIA Specialty Plate will still help a lot of Indiana Veterans in need.

Page 6 of the newsletter has important information for members with Rolling Thunder® patches. There are provisions in the constitution that affect members, and the Chapter, when patches are not returned should the member decides to resign. Lost or damaged Rolling Thunder® patches could be a financial impact to the member and Chapter if not handled properly. Please review page 6 and let me know if you have any questions.

SB316

March 16, 2021 – The bill was voted on by the House Veterans Affairs Committee and passed. The bill has been recommitted to the House Ways and Means committee.

March 30, 2021 - The bill had its 3rd reading and passed without amendments. The bill is now on its way to the Governor for signature.

Starting in July 2021, Veterans with less than Honorable discharges will have access to the MFRF fund and IDVA will be allowed to use 10% of the fund annually for advertisement expenses.

Roger Williams, the immediate past commander for AMVETS Department of Indiana wrote the below article in the Ft. Wayne Newspaper that suns up SB316.

Honor: it used to be more than just a word that reflected the choices you made for the country that are bigger than life.

In essence, honor represents the realization and appreciation of the service of "honorable" veterans. Without "honorable" veterans, we wouldn't be able to enjoy the same freedoms we do in this great country today. Unfortunately, it saddens us to think there is a bill that intends to twist and turn the true meaning of the word "honor."

The intention of Indiana Senate Bill 316 (Military and Veterans Programs) is to alter the eligibility of a military service member. (A fund administered by the state's Department of Veterans Affairs gives up to \$2,500 grants to eligible veterans in need.) For the sake of sanity and reason, it couldn't be clearer that grants to veterans discharged as "other than honorable" is a minefield.

Most people would argue that the bill is outright unethical and immoral. The fact that SB 316 may acknowledge and allow offenders to receive money from the fund should startle and outrage everyone. In the disguise of "other than honorable discharge" are individuals with courts-martial and other severe offenses. In fact, each branch of the military deals with such discharges in a specific manner.

Whether it's assault, security violation, possession of drugs, substance abuse, abuse of power or violation of civilian authorities, there are too many variables to move forward with SB 316. Moreover, the reasoning behind other than honorable discharges is a rabbit hole of serious offenses. It could be sexual misconduct, child pornography, fraudulent acts, disruptive behavior, failure to pay child support or served jail time.

To put things in perspective, there are almost 800 codes that fall under the other than honorable heading without clear or established variables. It is shameful to think that SB 316 might allow unfit (and some even monstrous) individuals to receive money from the fund.

The picture is clear; SB 316 would deem individuals with AWOL, assault and battery, vandalism, robbery, and even manslaughter records to get money from the fund. Despite constant reframing, it doesn't change the fact that these are not minor offenses.

The last thing you want is to be dissuaded by the false and empathetic approach of SB 316. It confuses and pushes you to indulge in the possibility of including individuals with "other than honorable" discharges.

The April Chapter meeting will be at the Indianapolis War Memorial (IWM) in the Pershing Auditorium. The meeting will start at 13:00 followed by a guided tour or a self-tour if the member prefers. 
Disable American Veteran (DAV) POW*MIA Chair of Honor

We recently had a conference call with the Carmel High School on installing a POW*MIA Chair of Honor in the school. We are looking forward to that opportunity.

Rolling Thunder®, Inc. Membership Patches and Obligations National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. A \$50.00 patch deposit is required before National will issue the Boot Patch.



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, which is the property of National. A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.

Membership Obligations

B) Retrieve Patches: It is the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.

If you mail your patches to the Chapter, make sure you send the package **CERTIFIED** or **PRIORITY** mail for tracking purposes and insure the package for \$150.00.



Military Family Relief Fund COVID-19 Special Application

Provides grants up to \$2,500 for qualified veterans whose current hardship is a result of the COVID-19 pandemic. Removes the service dates and military connectedness from the original Military Family Relief Fund program. Must provide documented proof of COVID-19 impact, typically through an email or letter from the veteran's place of employment on official letterhead.

Disabled Hoosier Veteran License Plate

For veterans with a service-connected disability rating of at least 30% for mobility issues, or for veterans that cannot walk without pain as a result of a service-connected disability, with physician verification. https://www.in.gov/dva/2385.htm

Tuition and Fee Exemption for Children of Disabled Veterans, Children of Purple Heart Recipients, and Children of POWs

Remission of tuition and fees for children of disabled veterans (at least 0% service-connected) who served during a period of war *or* participated in equally hazardous duty, or the children of Purple Heart Recipients, or the children of prisoners of war. May only be used at approved state-sponsored universities for up to 124 credits.

Tuition and Fee Exemption for Purple Heart Recipients

Recipients of the Purple Heart are eligible to receive a tuition and fee exemption at state-sponsored schools for up to 120 credits.

Property Tax Deduction for Veterans and Spouses of KIA

\$14,000 deduction for veterans that served during peace time *or* the surviving spouse of a service member that was killed in action or died during active duty. Veteran must be totally disabled *or* must be 62 years old with a 10% service-connected disability rating. There is an assessed value limit of \$200,000. https://www.in.gov/dva/2383.htm

Property Tax Deduction for Wartime Veterans

\$24,960 deduction for wartime veterans with at least a 10% service-connected disability rating. There is no assessed value limit for this benefit. https://www.in.gov/dva/2383.htm

Property Tax Combination for Certain Disabled Wartime Veterans

A veteran who served during a period of war and is at least 62 years old with a 10% service-connected disability rating OR has a permanent and total service-connected disability rating at any age AND whose home's assessed value is \$200,000 or less, can receive both property tax deductions for a total of \$38,960. https://www.in.gov/dva/2383.htm



Indiana POW/MIA Specialty Plates






