Rolling Thunder® Indiana Chapter 1 **Elections**

The June Chapter meeting was the start of our 2023 election cycle.

In accordance with the National Constitution, all members will be duly notified of elections by an announcement at the June, July and August Chapter meeting. Nominations will be taken at our July and August Chapter meetings only. You MUST be present to accept the Nomination.

To be nominated and/or elected for any officer position, a member must be in good standing for a period of (1) year or longer.

The member must have their Rocker/Eagle patches and have attended six (6) Chapter meetings in the past (12) months prior to nomination.

The election will be held at our September 17th Chapter Meeting.

The positions that will be up for election is the President, Secretary, (3) Board Members, and Alternate Board Member.

In accordance with the National Constitution, to be eligible for position of Chapter President, a member must have held a Chapter Executive Officer position or been a member of the Board of Directors for 12 months of a Chapter prior to being nominated. Under special circumstances a waiver may be granted by National.

In accordance with Chapter Rules Version 1.2, Any Chapter member in good standing wishing to run for the office of President, or Chairman of the Board, must first have held another office, i.e.: Treasure, Secretary, or Board member, for a full term with RTIN Chapter #1.



Chapter President Duties and Responsibilities Description

The Chapter President is an elected official with a (2) year term and is the Chief Executive Officer in charge of the daily operation of the Chapter. The Chapter President enhances the organization's public standing by clearly articulating the Rolling Thunder® mission statement, accomplishments, and goals to the public and garners support from the community.

The duties of the Chapter President will include, but not limited to the following duties.

- a. Responsible for the overall day-to-day operation, safety, management and financial order of the organization.
- b. The Chapter President ensures that all officers, board members and members follow the Constitution.
- c. The Chapter President sets the agenda and runs the monthly membership meetings and ensures all meetings are run according to the Constitution and Roberts Rules when applicable.
- d. The Chapter President gives agenda ideas for discussion to the Chairman of the Board for the Board Meetings. (The Chairman of the Board runs the Board Meeting).
- e. Must have held another office, i.e.: Treasure, Secretary, or Board member, for a full term with Indiana Chapter #1.
- f. Must not miss (3) consecutive meetings without legitimate excuse.
- g. The President is responsible to the Vice President of Rolling Thunder® Inc. National. In some cases, through the State Liaison, if in the chain of command.

Chapter Secretary **Duties and Responsibilities Description**

The Chapter Secretary is an elected official with a (2) year term. The Chapter Secretary attends and records the minutes of all meetings and is the records officer for the Chapter. The Chapter Secretary enhances the organization's public standing by clearly articulating the Rolling Thunder mission statement, accomplishments, and goals to the public and garners support from the community.

The duties of the Chapter Secretary will include, but not limited to the following duties.

- a. Recording, editing and maintaining all meeting minutes



Mary is the widow of an Air National Guardsman who served for 8 year. Mary had to have her leg amputated due to an infection and is completely wheelchair bound. Mary lives with her daughter and the home doesn't have a ramp for easy access .

Chapter Member Jim Smith brought this issue to the Board for consideration to have a ramp built for Mary so she could have easier access to her home. The Board reviewed the cost estimates and approved the expense for the ramp to be built. The expense was brought up to the membership for discussion and vote, and the membership voted unanimously to support building the ramp for Ms. Nicholson.

The contractor started building the ramp the same week, and completed the project on July 22nd. Below is some pictures of before and after the ramp was built.

USS Indianapolis Honor Watch Sunday July 30, 2023

Sunday July 30th was the 78th anniversary of the torpedoing and sinking of the USS Indianapolis CA-35. **The USS Indianapolis had a proud war record**: 10 battle stars, Flagship of Admiral Raymond Spruance (Spurance), and President Franklin Roosevelt's ship of state. Because of her remarkable war record, and her speed as a heavy cruiser, the USS Indianapolis was chosen for the top secret mission to deliver the Uranium 235 to the island of Tinian. From there, the Enola Gay dropped the atomic bomb "Little Boy" over the city of Hiroshima. After Nagasaki was bombed, Japan surrendered.

There is only one USS Indianapolis survivor still alive. His name is Harold Bray. There is only one survivor from the I- 58 Japanese submarine that sank the USS Indianapolis. The crewman's name is Kunshirou Kiyozumi. Harold Bray and several members of the Legacy Education Committee, including lost at sea families, wrote to Mr. Kiyozumi. The letters were to assure Mr. Kiyozumi that the benevolent message was of forgiveness and peace

Izumi Harris, a special friend of the Honor Watch, is an Indiana college professor. Izumi hand-delivered the letters to Mr. Kyozumi in Japan. Members of the Legacy Education Committee read some of the letters to Mr. Kyozumi, and his replies back to us to the Committee.

Chapter Members Jackie Griffith, Darryle Swartzlander, Terry Sanderson, Ed Newbill, Jessica Clark, and David Brewer, read the names and bio's of the 31 Hoosier Heroes that lost their lives when the USS Indianapolis was sunk by the Japanese.

Thomas Barksdale, Fire Controlman Third Class, son to Mr. and Mrs. Andrew Barksdale from Seymour. He reported for duty aboard the USS Indianapolis on November 8, 1943. Leon was 20 years old when he was lost at sea.

Robert Biltz, Seaman Second Class, son of Mr. and Mrs. Lewis J. Biltz from Elkhart. He reported for duty aboard the USS Indianapolis in July 1945. Robert was 18 years old when he was lost sea.

Eldridge Wayne Bowles, Seaman lst Class, husband to Kathleen Bowles, father to Sandra Rigdon, from Camby. He reported for duty aboard the USS Indianapolis on October 8, 1943. Eldridge was 31 years old when he was lost sea.

Paul Edward Gill, Water Tender Second Class, son of Mr. and Mrs. Edward Gill from Huntington. He reported for duty aboard the USS Indianapolis on September 1, 1943. Paul was 25 years old when he was lost at sea

David Elmer Crimes. Seaman Second Class, son of Mr. and Mrs. Eugene Crimes from Russellville. He reported for duty aboard the USS Indianapolis on May 7, 1944. David was 20 years old when he was lost at sea.

Loren Everett Grimm, Marine Private First Class, son to Mr. and Mrs. William Grimm from Montezuma. He reported for duty aboard the USS Indianapolis in April 1944. Loren was 27 years old when he was lost at sea.

John Thomas Groch, Machinist Mate Third class, son of Mr. and Mrs. Adolph Groch from Michigan City. He reported for duty aboard the USS Indianapolis on April 27, 1944. John was 33 years old when he was lost at sea.

Morgan Guenther, Electrician Mate Third Class, husband to Mrs. Alma Guenther, from Granite City. He reported for duty aboard the USS Indianapolis on May 5, 1943. Morgan was 23 years old when he was lost at sea.

John William Hodshire, Seaman Second Class, son of Mr. and Mrs. Glen Hodshire from Greencastle. He reported for duty aboard the USS Indianapolis on May 7, 1944. John was 19 years old when he was lost at sea.

Prentice William Hopper, Seaman First Class, son of Audie Hopper from Winslow. He reported for duty aboard the USS Indianapolis on June 1, 1945. Prentice was 18 years old when he was lost at sea.

Roy Lee Hopper, Aviation Mechanic First Class, husband to Dora Hopper from Decatur. He reported for duty aboard the USS Indianapolis on June 2,1945. Roy was 31 years old when he was lost at sea.

Wallace Jeffers, Coxswain, son of Wallace Jeffers, Great Uncle to Jeff Sweeney, from New Albany. He reported for duty aboard the USS Indianapolis on a July 22, 1943. Wallace was 29 years old when he was lost at sea.

Glenn Willis Kenworth, Marine Corporal, husband to Norma Kenworth from Kokomo. He reported for duty aboard the USS Indianapolis in April 1944. Glenn was 27 years old when he was lost at sea.

The Wall that Heals



The honoree is CWO 5 Jeff Houser who was shot down over Cambodia. CWO Houser, along with his observer and his gunman, were reported missing in action. CWO Houser walked out of the jungle almost four days later. Unfortunately, his observer was killed in action, and his door gunner is still listed as MIA.


Indiana POW/MIA Specialty Plates on the Streets As of June 30, 2023

Rolling Thunder®, Inc. Membership Patches and Obligations National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. A \$50.00 patch deposit is required before National will issue the Boot Patch.



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, which is the property of National. A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.

Membership Obligations

Retrieve Patches: It's the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.

If you mail your patches to the Chapter, make sure you send the package **CERTIFIED** or **PRIORITY** mail for tracking purposes and insure the package for \$150.00.

Please DO NOT Glue your patches on your vest. National will NOT accept damaged patches and you may lose your patch refund.


