# Indiana Military Veterans Legislative Day

### January 27, 2020

Some of the best looking Chapter members attended the Indiana Military Veterans Legislative Day event at the State Capitol on Monday January 27th. There were several Veteran and Military organization at the event to give an update on their events and initiatives.

We did get an opportunity to speak with State Representative John Bartlett about supporting a State POW/MIA Flag Act bill for the State of Indian. The purpose of the bill will be to fly the POW/MIA Flag on top of the State Capitol and other State facilities every day the American flag is flown. This bill will be similar to the National POW/MIA Flag Act that was signed into law by President Trump on November 7th, 2019, but for State instead of Federal.





# **Chapter Rule Changes**

At the January 19, 2020 Chapter meeting, we had a members only discussion about the Chapters Vice President position and the eligibility of members that can run for the office of Vice President within Indiana Chapter 1. The Chapter rules that were published on January 26, 2014 required that a member running for the office of the Vice President position must first have held another office, i.e.: Treasure, Secretary, or Board member, for a **full term**, with RTIN Chapter #1.

This rule was discussed in great detail on how the rule is limiting members to be able to run for the Office of Vice President within the Chapter,

In accordance with the Rolling Thunder® National Constitution, a member being nominated for any office (with the exception of President) must be in good standing for a period of (1) year or longer. The person must be a full member at the time of nomination and have earned their patches. The member must also have attended (6) Chapter meetings, prior to nomination in the past (12) months.

The Chapter members voted on the Chapter Rule change (22) to (15) in favor of the Chapter Rule Change. Below is the Chapter rule that was implemented January 26, 2014 and the new Chapter Rule dated January 19, 2020.

#### Chapter Rule Dated January 26, 2014:

#### Additional requirements for Office of President, Vice President and Chairman of the Board.

Any Chapter member in good standing wishing to run for the office of, President, Vice President, or Chairman of the Board, must first have held another office, i.e.: Treasure, Secretary, or Board member, for a full term, with RTIN Chapter #1.

#### New Chapter Rule Dated January 19, 2020:

#### Additional requirements for Office of President, and Chairman of the Board.

Any Chapter member in good standing wishing to run for the office of President, or Chairman of the Board, must first have held another office, i.e.: Treasure, Secretary, or Board member, for a full term with RTIN Chapter 1.

# The change would allow any member that meets the requirements within the Rolling Thunder® National constitution to run for an officer position.

#### **Please Note:**

The office of the Vice President is currently vacant and needs to be filled with a qualified Chapter Member. At the February 16, 2020 Chapter Meeting, nominations will be taken for the office of the Vice President for Indiana Chapter 1. A list of eligible members based on the National Constitution requirements will be provide at the Chapter meeting. Nominations will only be made at the February 16, 2020 Chapter meeting.

If there is only 1 candidate that runs unopposed, he or she will become the new Vice President at the February 16th Chapter meeting.

If multiple candidates run for the office of the Vice President, there will be a special election at the March 15, 2020 Chapter meeting. **Your vote counts, so please plan on attending**.

#### Specialist Tim Senkowski Donation

Specialist Tim Senkowski is a Indiana wounded warrior from Anderson, Indiana. He served in the US Army from 2007 to 2013 when he was medically discharged due to injuries suffered while serving in Afghanistan. Tim's injuries include the loss of both legs above the knees, loss of numerous fingers on the left hand, loss of the use of the left hand. Tim was the victim of a remotely detonated IED.

Tim is married, he and his wife have three young children. His wife is also disabled, and because of her disabilities she cannot care for Tim. She is legally blind, suffers from lupus and rheumatoid arthritis. Tim is cared for by his mother Tamra Rigdon, who by the way, also cares for her disabled daughter (also a veter-an).

Tim currently has a handicapped accessible pickup truck and is no longer suitable as a family transport vehicle.

The Road Home Foundation contacted the Chapter to see if we may be able to help with the purchase of a 2019, handicapped accessible Ram Promaster Van for the Senkowski family. The cost of the van fully equipped for accessibility is \$87,031.

The Road Home Foundation has raised \$78,031 towards the purchase of the van from the following organizations; Veterans Administration - \$47,031, Sempre Fi Fund - \$20,000, Operation Jersey Cares - \$5,000, and the Road Home Foundation - \$6,000.

The donation for the Senkowski family was discussed with the Board Members at the January 19, 2020 Board meeting and was approved for \$5,000 donation. The \$5,000 donation was brought before the Chapter membership for their vote and was approved.


The funds in the Chapters Charities account was used for the donation. This is another example of Indiana Chapter 1 helping our Indiana Wounded Warriors in need.

# Please continue seeking donations in 2020 so the Chapter can continue with helping or Indiana Veterans in need, and our POW/MIA mission.


# 2020 Chapter Budget

A budget is a plan for the coordination of resources and expenditures for a given period of time. Our budget is based on estimates as best they can be currently anticipated. This budget becomes the framework that will drive the operations of the chapter by the Board and Officers for 2020.

The 2020 Chapter budget was briefed at the January 19, 2020 Chapter meeting and approved by all. As you can see from the below revenue chart, Donations and Sponsorship will have the biggest impact to the Chapters revenue in 2020. We'll need funding to continue on with our POW/MIA mission. The POW\*MIA Chairs of Honor, Flag donations, and helping our Indiana Veterans all take funding. Please continue seeking donations and sponsorship in 2020. # The below chart shows the breakdown on the projected expenditures for 2020. As you can see from the below chart, the General expenditures is the largest piece of the pie. These are the operating expenses that keep the Chapter operational. These expenditures include, Accounting Services, Awards, Bank Fees, Flowers, HVAF (luncheon), Insurance, National Convention, National Raffle, Office Supplies & Stationery, Postage and Mailing, Internet, State Director, Veteran's Center, Web Service, and Other.



#### Marine PFC Louis Wiesehan WWII MIA



The Defense POW/MIA Accounting Agency (DPAA) announced today that Marine Corps Pfc. Louis Wiesehan, Jr., 20, of Richmond, Indiana, killed during World War II, was accounted for on Sep. 23, 2019.

In November 1943, Wiesehan was a member of Company F, 2nd Battalion, 8th Marine Regiment, 2nd Marine Division, which landed against stiff Japanese resistance on the small island of Betio in the Tarawa Atoll of the Gilbert Islands in an attempt to secure the island. Over several days of intense fighting at Tarawa, approximately 1,000 Marines and Sailors were killed and more than 2,000 were wounded, while the Japanese were virtually annihilated. Wiesehan was killed on the second day of the battle, Nov. 21, 1943. His remains were reportedly buried in Division Cemetery on Betio Island.

In 1946, the 604th Quartermaster Graves Registration Company centralized all of the American remains found on Tarawa at Lone Palm Cemetery for later repatriation; however, almost half of the known casualties were never found. No recovered remains could be associated with Wiesehan, and in October 1949, a Board of Review declared him "non-recoverable."

To identify Wiesehan's remains, scientists from DPAA used anthropological analysis, as well as material evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA (mtDNA) analysis. Wiesehan's name is recorded on the Courts of the Missing at the Punchbowl, along with the others killed or lost in WWII. A rosette will be placed next to his name to indicate he has been accounted for,

#### PFC Wiesehan will be buried April 18, 2020, in his hometown of Richmond Indiana.

Once we know when PFC Weisehan will arrive at the Indianapolis Airport, we will notify everyone and participate in the escort to Richmond Indiana. Please plan on attending PFC Wiesehan's funeral services on April 18th. The Wiesehan family will appreciate us being there.



# Indiana POW/MIA Specialty Plates on the Streets






