

Allies in Healing by Jill Drummond

Fifty years after the end of the Vietnam War, *Allies in Healing: A Couple's Toolkit of Resources for Recovering from Combat PTSD* (Bowker Identifier Services, 308 pp. \$15.50, paper; \$9.99 Kindle) contains insights that are relevant for Vietnam War veterans and their families, as well as for veterans of the wars in Iraq and Afghanistan. Survivors of other kinds of traumas, including mass shootings and natural disasters, also may find it helpful.

Jill Drummond is a Ph.D psychologist whose husband David Drummond was a B-52 pilot shot down over North Vietnam in December 1972 and held as a POW before being released in March 1973 during Operation Homecoming following the signing of

the Paris Peace Accords. The book is unique in that it reflects the lived experience of a married couple, not that of a detached clinical professional.

Drummond compares family members' secondary PTSD to the effects of second-hand smoke when a non-smoker lives with a cigarette smoker. Anxiety, depression, and other behaviors may be transmitted to children, which can damage their own relationships in adulthood.

The book is divided into five parts, with 12 chapters and subheadings. The most important chapter is devoted to "Five Master Skills" to manage PTSD: mindfulness, body awareness, experiencing rather than avoiding, letting go, and embodying intentions.

The skills underlie treatment and practices that can lead both to recovery and personal growth. Other sections address practical issues, including how to choose a therapist, medication side-effects, "rethinking the use of alcohol," and communicating with a partner and other family members.

Drummond argues especially that "medication is prescribed far too often when other treatments can be just as effective [and] medication alone, without counseling, is a poor choice."

Blocks of italicized personal reflections are interspersed with the regular text, which itself has a casual tone. At one point, Drummond admits that she often found it hard to understand how her husband's combat experiences related to his aggressive or debilitating behaviors. "It felt as though we were flying blind through unfamiliar and hostile territory without a map," she writes. "Fortunately, I found out there are lots of maps available once you know where to look.

David Drummond credits individual and group therapy, couples counseling, meditation, and yoga. "All of these methods combined to create an atmosphere that allowed me to improve," he says in the book. "Someone doesn't make you better; you heal yourself. Like with any disease or injury, other people just guide you and help you on your path. It is sometimes a difficult and frustrating journey, but it is worth the effort to recover your life."

Col DONALD WILLIAM DOWNING UNITED STATES AIR FORCE Accounted for December 20, 2024

Lieutenant Colonel Downing entered the U.S. Air Force from **Wisconsin** and served in the 557th Tactical Fighter Squadron, 12th Tactical Fighter Wing. In September 1967, he held the rank of Captain. On September 5, he and another aviator made up the crew of an F-4C Phantom II (tail number 63-7547, call sign "Sharkbait 42") conducting a nighttime armed reconnaissance flight over Quang Binh Province, North Vietnam. As "Sharkbait 42" and another U.S. plane approached a target, the other crew reported seeing a fireball and losing radio contact with Capt Downing. Search and rescue efforts began at daylight, but electronic and visual searches didn't find anything.

On April 28, 1978, the U.S. Air Force declared Capt Downing Killed in Action. He was later posthumously promoted to the rank of Lieutenant Colonel. After decades of investigation into the incident yielding no results, a Joint Field Activity team recovered life support equipment, possible material evidence, aircraft wreckage, unexploded ordnance, and possible osseous material at a site in Quang Binh Province in May and June 2024.

Evidence from the mission was accessioned into the DPAA laboratory in June 2024. The laboratory analysis and the totality of the circumstantial evidence available allowed Lt Col Downing to be identified from remains recovered from the crash site.

Another Vietnam War Veteran finally made it home.





Indiana POW/MIA Specialty Plates on the Streets As of January, 2025



As of January 31, 2025, we have **4,876** POW/MIA specialty plates on the streets of Indiana helping to bring awareness to the public about our POWs, and MIAs. The funds generated from the sale of the POW/MIA Specialty plate goes towards helping our Indiana Veterans in need through the Indiana Military Family Relief Fund (MFRF). **223** plates were Renewed/Sold in January 2025.

Indiana POW/MIA Specialty Plate Fund From 2010 to 2025



Since the introduction of the Indiana POW/MIA Specialty Plate in January 2010, the plate has generated an estimated \$1,427,450. 100% of the proceeds generated from the sales of the POW/MIA specialty plate goes to the Indiana Military Family Relief Fund (MFRF) to help our Indiana Veterans in need.

If you don't have a Indiana POW/MIA Specialty Plate on your vehicle, please let the Bureau Motor Vehicle (BMV) know that you would like to purchase a Rolling Thunder® sponsored POW/MIA specialty plate on your next renewal or new purchase.

With the purchase of a Indiana POW/MIA specialty plate, not only will you be instrumental in helping to bring awareness to the public about our POWs and MIAs, you will be helping our Indiana Veterans in need.

Chapter Scholarship Program





The Chapter is giving back to the family members of our Indiana heroes by offering a \$1,000 scholarship to a high school senior or student receiving the GED, seeking a higher education at an accredited college, university, or trade school. This scholarship opportunity is only available to family members that are residents of Indiana and have a verifiable family relationship to a former POW or MIA.

The Chapter Scholarship started in 2021 and has help four of our MIA families in continuing their education to better their lives. The Chapter has generously donated \$4,000 in Scholarship funds to our MIA family members since 2021.

To be eligible for this Scholarship, the applicant must be a resident of Indiana and have a verifiable familial relationship to a former Prisoner of War (POW) or Missing in Action (MIA). The student applying for the scholarship will be required to independently write an essay on a POW/MIA themed topic of their choosing. The theme of the essay should be original and based on an event, person, philosophy or ideal.

Possible topic themes might be a discussion of POWs during a particular war (Revolutionary War, Civil War, WWI, etc.), POW encampments such as in Andersonville, Georgia, Camp Atterbury, Camp Morton, internment camps of Japanese-Americans during WWII.

The deadline for application submission is **April 30**, 2025. Winner announcement and scholarship award will be made by June 30, 2024.

Rolling Thunder®, Inc. Membership Patches and Obligations National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. A \$50.00 patch deposit is required before National will issue the Boot Patch.



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, which is the property of National. A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.

Membership Obligations

Retrieve Patches: It's the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.

If you mail your patches to the Chapter, make sure you send the package **<u>CERTIFIED</u>** or **<u>PRIORITY</u>** mail for tracking purposes and insure the package for \$150.00.

Please DO NOT Glue your patches on your vest. National will NOT accept damaged patches and you may lose your patch refund.

2025 Membership Dues

In accordance with the National constitution, the membership dues are required to be paid to National by March to remain a member in good standing.

Membership is important to keep the Chapter going so we can continue on with our important POW/MIA mission and helping our Indiana Veterans. Without members in good standing, the Chapter would not be able to do our important missions.

Please help the Chapter remain successful and pay your membership dues as soon as possible, **but no later than February 16, 2025**. We do appreciate your membership.


