## CWO John William Frederick JR Born: December 13, 1923 Died while in Captivity: July 19 1972



Chief Warrant Officer John William Frederick, Jr United States Marine Corps, was held as a Prisoner of War in North Vietnam from December 7, 1965 until his death in captivity on or about July 19, 1972.

John William Frederick Jr was born and raised in Manito, Illinois. He was the son of John William Frederick and Estella Inez Fuller. He had married Lorraine Wilma Unsicker in 1948.

On May 7, 1942, he enlisted in the US Marine Corps to serve during World War II and flew 40 combat missions in the Pacific Theater as a tail gunner and radar operator on Grumman TBF Avenger torpedo bombers.

He went on to serve during the Korean War and was awarded the Distinguished Flying Cross. He served as Pilot and Airborne Intercept Operator attached to the 542nd Marine All Weather Fighter Squadron. He flew over 90 combat missions in Grumman F7F Tigercats.

On December 1, 1965 he was deployed to Vietnam. One week later, on the night of December 7, 1965 Frederick was the radar intercept officer of an F4B Phantom during an escort mission out of Da Nang Air Base. Their aircraft was shot down by a surface-to-air missile over North Vietnam. Although he severely burned his hands when his part of the cockpit was enveloped by flames, he successfully ejected from the aircraft. His pilot, Major John H Dunn, also survived the crash and was captured six days later.

The next morning, Frederick accidentally walked into an enemy gun emplacement and single-handedly attacked them. He managed to kill a few North Vietnamese soldiers before he was overpowered and captured. Frederick was subsequently beaten and taken to a prisoner of war camp in Hanoi.

As one of the first Marines held as a POW, Frederick helped set the standard for conduct of other captured Marines. He strictly adhered to the code of conduct and refused to take part in North Vietnamese propaganda programs. His resistance to the enemy also caused him to be routinely tortured and beaten during numerous interrogations.

He was subjected to long periods of solitary confinement for refusing to bow and or provide information. In 1972, he was held in solitary confinement for 90 days and contracted either typhoid fever or meningitis. Falling into a coma, Frederick was likely being transported to a hospital in Hanoi when he died on or about July 19, 1972, after more than 2,400 days in captivity.

During his service in the Vietnam War era, he was posthumously awarded the Navy Cross, Silver Star and Legion of Merit for conspicuous gallantry and intrepidity while interned as a Prisoner of War. He had been recommended for the Medal of Honor, however this award was downgraded to the Navy Cross.

Despite severe injuries which resulted from maltreatment and severe cruelties, Chief Warrant Officer Frederick steadfastly refused to cooperate with his captors in their attempt to gain tactical information.

Although long periods of solitary confinement for such offenses as refusing to bow or provide biographical information weakened his physical condition, he was not detracted from his dogged resistance. Refusing at all times to give in to the enemy, he provided a personal example and source of strength to his fellow prisoners.

With full knowledge that his tenacious resistance could only arouse worse treatment, he showed extraordinary courage and determination, adhering to a Code of Conduct to an extent far beyond that which could reasonably be expected.

By his resourcefulness and leadership in the face of great adversity, Chief Warrant Officer Frederick reflected great credit upon himself and upheld the highest traditions of the Marine Corps and the United States Naval Service.

# Operation Homecoming February 12, 1973 to April 4, 1973

On January 27, 1973, Henry Kissinger (then assistant to President Richard Nixon for national security affairs) agreed to a ceasefire with representatives of North Vietnam that provided for the withdrawal of American military forces from South Vietnam. The agreement also postulated for the release of nearly 600 American prisoners of war (POWs) held by North Vietnam and its allies within 60 days of the withdrawal of U.S. troops. The deal would come to be known as Operation Homecoming and was divided into three phases. The first phase required the initial reception of prisoners at three release sites: POWs held by the Viet Cong (VC) were to be flown by helicopter to Saigon, POWs held by the People's Army of Vietnam (PAVN) were released in Hanoi and the three POWs held in China were to be freed in Hong Kong. The former prisoners were to then be flown to Clark Air Base in the Philippines where they were to be processed at a reception center, debriefed, and receive a physical examination. The final phase was the relocation of the POWs to military hospitals.

On February 12, 1973, three C-141 transports flew to Hanoi, North Vietnam, and one C-9A aircraft was sent to Saigon, South Vietnam to pick up released prisoners of war. The first flight of 40 U.S. prisoners of war left Hanoi in a C-141A, which later became known as the "Hanoi Taxi" and is now in a museum.

From February 12 to April 4, there were 54 C-141 missions flying out of Hanoi, bringing the former POWs home. During the early part of Operation Homecoming, groups of POWs released were selected on the basis of longest length of time in prison. The first group had spent six to eight years as prisoners of war. The last POWs were turned over to allied hands on March 29, 1973 raising the total number of Americans returned to 591.

Of the POWs repatriated to the United States a total of 325 of them served in the United States Air Force, a majority of which were bomber pilots shot down over North Vietnam or VC controlled territory. The remaining 266 consisted of 138 United States Naval personnel, 77 soldiers serving in the United States Army, 26 United States Marines and 25 civilian employees of American government agencies. A majority of the prisoners were held at camps in North Vietnam, however some POWs were held in at various locations throughout Southeast Asia. A total of 69 POWs were held in South Vietnam by the VC and would eventually leave the country aboard flights from Loc Ninh, while only nine POWs were released from Laos, as well as an additional three from China.

## National Former POW Recognition Day April 9th

National Former Prisoner of War Recognition Day observed annually on April 9 recognizes and honors the courageous prisoners of war (POW) and those who are still missing in action (MIA). Did you know that prisoners of war must be treated decently with respect? Yes, although they are prisoners of war, they will be allowed to have all the basic rights. On this day, back in 1942, American veterans were held by the Japanese and endured harsh treatment. While some survived, there were countless numbers of people that died on their way to the prison camps.

#### HISTORY OF NATIONAL FORMER PRISONER OF WAR RECOGNITION DAY

War is a brutal act that humans have carried out ever since they learned to use sticks and stones as weapons. Prisoners of War (POW), the people who are captured by the opposition party as prisoners during the war, often endure atrocious treatment. National Former Prisoner of War Recognition Day aims to honor those courageous fighters of the nation who had to endure

National Former Prisoners of War Recognition Day occurs on the anniversary of the Bataan Death march. On April 9, 1942, the United States Forces surrendered to the Imperial Japanese Army on the Bataan Peninsula. All Survivors were loaded to a box train and brought to Camp O'Donnell. During this march, POWs were physically abused and tortured, causing the death of over 500 Americans. This is called the Bataan Death March. Later, this action of the Japanese Army was judged to be a Japanese War Crime.

In 1984, former POWs led a movement to recognize April 9, the day of the Bataan Death March, as the National Former Prisoner of War Recognition Day. On April 1, 1988, President Ronald Reagan proclaimed April 9 be set aside to recognize the brave veterans. Reagan announced the holiday through the Presidential Proclamation 5788, and congress agreed with the legislation. Since then, on this day, every year, government officials, veterans, civic and private organizations across the nation observe this day with ceremonies and events.

#### NATIONAL FORMER PRISONER OF WAR RECOGNITION DAY TIMELINE

#### 1942 - Japanese Troops Capture U.S. Forces

The largest number of U.S. Forces are captured by Japanese troops in the Bataan peninsula.

#### 1973 - Vietnam War Veterans Day

The last U.S. combat troops depart the Republic of Vietnam.

#### 1984 - The Start of The Movement

Former POWs lead the movement seeking a day recognizing POWs.

#### 1988 - Approval of The Legislation

Congress approves the legislation, setting April 9 as the National Former Prisoner of War Recognition Day.

#### **Proclamation 5788**

## National Former Prisoners of War Recognition Day, 1988

By the President of the United States of America

#### **A Proclamation**

It is truly fitting that America observe April 9 in recognition of our former prisoners of war; that date is the 46th anniversary of the day in 1942 when U.S. forces holding out on the Bataan Peninsula in the Philippines were captured. Later, as prisoners of war, these gallant Americans were subjected to the infamous Bataan Death March and to other inhumane treatment that killed thousands of them before they could be liberated. In every conflict, brutality has invariably been meted out to American prisoners of war; on April 9 and every day, we must remember with solemn pride and gratitude that valor and tenacity have ever been our prisoners' response.

That is clear from the words of then-Captain Jeremiah Denton, USN, when he and other U.S. prisoners of war were freed in 1973 after years of captivity in North Vietnam. "We are honored to have had the opportunity to serve our country under these difficult circumstances," Captain Denton said. Implacable and incredible courage, endurance, faith, and patriotism were behind those words—eloquent and immortal testimony to the spirit of America's Armed Forces in the Vietnam War and throughout our history.

The term "difficult circumstances" referred to nothing less than physical and mental torture, starvation, disease, separation from loved ones, and deprivation of medical treatment—an ordeal that for some, in every conflict, did not end until death. To their brave families we offer solace and salute. To our former prisoners of war who endured so much, we say that with your example and with God's help we will seek to meet the standards of devotion you have set; we will never forget your service or your sacrifice.

The Congress, by Public Law 100-269, has designated April 9, 1988, as "National Former Prisoners of War Recognition Day" and authorized and requested the President to issue a proclamation in observance of this event.

*Now, Therefore, I, Ronald Reagan, President of the United States of America, do hereby proclaim April 9,* 1988, as National Former Prisoners of War Recognition Day, and I urge all Americans to observe this day of remembrance with appropriate ceremonies and activities.

*In Witness Whereof,* I have hereunto set my hand this first day of April, in the year of our Lord nineteen hundred and eightyeight, and of the Independence of the United States of America the two hundred and twelfth.

#### **Chapter Events**: 55

The Chapter completed approximately 55 events in 2022 not including Chapter meetings. Some events were well attended and others would have made a bigger statement with more members in attendance. Some of the significant events included:

March 29th - Jessica Lynch Briefing at the IWM. Jessica was a POW during the IRAQ War and told her story while in captivity as a POW.

May 14th - Richard (Dick) Harrington Celebration of Life and Escort. The Chapter had a celebration of life for Chapter Member Dick Harrington at the Veterans Center. Upon conclusion of the Celebration of Life, the Chapter with family members and friends escorted Dicks remains to the Indiana Veterans Memorial Cemetery in Madison, IN. We had approximately 25 member in attendance.

May 29th - Rolling Thunder® XXXIV Ride for Freedom. This event took place at the American Legion Plaza downtown Indianapolis. We had approximately 29 members in attendance with 20 guest.

July 21st-26 - Linda Smith-Cope Memorial Ride to the Wall. Chapter and family members escorted Linda's remains to the Vietnam Memorial Wall in Washington DC to be with her brother, SFC Ronald Eugene Smith. Ron went missing in Vietnam in 1970, and listed on the wall. Family members spread Linda's ashes near the wall were she will be with her brother forever. We had approximately 21 Chapter and family members that joined us on this event.

**August 27th - Veterans Center Support Ride.** This is an annual event to help raise funds for the Fort Harrison Veterans Center. The event was a scavenger hunt organized by Don and Wendy Leasure. Don and Wendy did an outstanding job with the event and raised \$4,223.97 for the Veterans Center. We had approximately 23 members in attendance with a few guest.

September 16th - POW/MIA Recognition Day and Escort. The POW/MIA Recognition Day Escort and Ceremony is an annual event that occurs on the third Friday in September. The Chapter was honored this year to escort six MIA families from the Fort Harrison Veterans Center to the Indiana War Memorial for the POW/MIA Recognition Day Ceremony. The guest speaker Suzanne Hoff Ogawa, who is the Daughter of Mary Helen Hoff and Commander Michael George Hoff, who went missing during the Vietnam War. Ms. Ogawa's mother Mary Helen Hoff was instrumental in designing of the POW/MIA Flag. Ms. Ogawa presented a POW/MIA 50th year anniversary banner to the Indiana POW/MIA Recognition Day Committee to be on permanently on display in the Indiana War Memorial Museum. We had approximately 21 members in attendance with several guest.

November 14th - Purdue POW\*MIA Chair of Honor Dedication. This was a special event where the Chapter dedicated its 14th POW\*MIA Chair of Honor. The dedication took place at the Purdue University in the Union Memorial. The Chair was unveiled by President Daniels and President-Elect Chiang. This special Chair will be seen by thousands of Purdue University students for many years to come. We had approximately 20 members in attendance with several Purdue guests.

**November 14th - Stoops Trucking POW/MIA Flag Raising Ceremony.** Upon conclusion of the POW\*MIA Chair of Honor dedication, members drove to Stoops Trucking in Lafayette Indiana to conduct a POW/MIA Flag of Honor ceremony. The ceremony was attended by 14 Chapter members and several guest from Stoops Trucking.

**December 4th - Chapter Christmas Party**. The committee members did an outstanding job organizing this years Christmas party at the American Legion post 34. We had approximately 30 members in attendance with several family members.

In conclusion, all 55 of our Chapter events were important and hope that we can have many more in 2023.

**Sponsorship/Fund Raising** - Sponsorship and Fund Raising is an important part of the financial health of the Chapter. The Chapter would not be able to do our mission without funding. Due to the hard work of Chapter members going out and getting sponsors and donations, the Chapter collected \$14,115 in donations for 2022. Special thanks to all of our Sponsors and Chapter members that helped in collecting donations.

Supporting our Veterans - The Chapter worked hard in supporting our Veterans in 2022 in many ways.

- 1. Indiana POW/MIA License Plate: The Indiana POW/MIA License Plate is a special tool that has two purposes. First, the POW/MIA License Plate helps bring awareness to the public about our POWs and MIAs, Secondly, the funds generated from the plate helps our Indiana Veterans in need. As of December 31st there are 4,795 POW/MIA License plates on the streets of Indiana. In 2022, the plate has generated \$113,225 dollars to help our Indiana Veterans through the Indiana Military Family Relief Fund. Unfortunately, in 2022 compared to 2021, we are down 36 plates and \$1,900 in plates sales. We need to find better ways to advertise this special plate.
- 2. BINGO at the Indiana Veterans Home: Every year the Chapter plays BINGO with our Veterans at the Indiana Veterans Home in Lafayette Indiana. Every year the Veterans that play BINGO with the Chapter walks away with money in their pocket. In 2022, the Chapter payed out \$1,940 to the Veterans.

- 3. Christmas Gifts for HVAF Veterans: In 2022, the Chapter purchased Christmas Gifts for 12 HVAF Veterans. The gifts included Hygiene kits, Winter gloves, Thermo underwear, Sock Hat, Small comfort blanket, Winter socks and Hand Warmers, etc. The total amount for the gifts was \$756.92.
- 4. **Pets Healing Vets**: The Pets Healing Vets program is an important program for our Veterans that suffer from PTSD and other issues. A K9 buddy helps the Veteran to cope with daily challenges. The Chapter made a \$500 donation to the Pets Healing Vets program at the March Chapter meeting and another \$500 donation at the Ruff Ride in October for a total of **\$1,000** in 2022.
- 5. **Indy Honor Flights**: The Chapter has participated in the Welcome Home Celebrations for the Veterans returning home after visiting their monuments in Washington DC. Chapter members greeted Veterans at the Airport as they debark their airplane and at the Welcome Home celebration at the High School.

**Scholarships** - The Chapter had two Scholarship offers in 2022.

- 1. **Linda Smith-Cope Scholarship**. This is a \$1,000 scholarship to be awarded to a Covington Community High School graduating senior seeking a higher education at an accredited College, University, or Trade School. The topic for the 2022 scholarship was "**The History of United States Prisoner of War (POW) and Missing in Action (MIA)".** The Chapter received one application for this scholarship. Vivian Jacobs of Covington, IN submitted her application and was awarded the \$1,000 scholarship. Vivian will continue her education at Hanover College.
- 2. **Chapter Scholarship**. This is a \$1,000 scholarship to be awarded to a high school graduating senior or a student receiving the GED seeking a higher education at an accredited college, university, or trade school. The topic for the scholarship is the same at the Linda Smith-Cope scholarship. The applicant for this scholarship must be a resident of Indiana, and have a verifiable family relationship to a former Prisoner of War (POW) or an Missing in Action (MIA). The purpose of this scholarship is to give back to the families that have sacrificed the lost of a loved one in war that remains unaccounted-for. Unfortunately, the Chapter did not receive any applications for this scholarship.

We have many more things to accomplish in 2023 and will need your membership to continue on with our POW/MIA mission and helping our Indiana Veterans. # Rolling Thunder®, Inc. Indiana Chapter #1 Scholarship 2022






# Indiana POW/MIA Specialty Plates on the Streets As of December 31, 2022



As of December, 2022 we have **4,792** POW/MIA specialty plates on the streets of Indiana helping to bring awareness to the public about our POWs, and MIAs. The funds generated from the sale of the POW/MIA Specialty plate goes towards helping our Indiana Veterans in need through the Indiana Military Family Relief Fund (MFRF). In December 2021, we had **4,828** POW/MIA specialty plates on the street compared to the 4,792 in December 2022. We are down by 36 plates and need to find ways to better advertise the POW/MIA Specialty plate to the public in 2023.

# Indiana POW/MIA Specialty Plate Fund From 2010 to 2022



Since the introduction of the Indiana POW/MIA Specialty Plate in January 2010, the plate has generated an estimated \$1,180,150. 100% of the proceeds generated from the sales of the POW/MIA specialty plate goes to the Indiana Military Family Relief Fund (MFRF) to help our Indiana Veterans in need.

If you don't have a Indiana POW/MIA Specialty Plate on your vehicle, please let the Bureau Motor Vehicle (BMV) know that you would like to purchase a Rolling Thunder® sponsored POW/MIA specialty plate on your next renewal or new purchase.

With the purchase of a Indiana POW/MIA specialty plate, not only will you be instrumental in helping to bring awareness to the public about our POWs and MIAs, you will be helping our Indiana Veterans in need.

2022 is the first year that the plate sales has not exceeded the previous year sales. We are down \$1,900 in sales compared to 2021. We need to find ways to better advertise this special plate to the public in 2023.

# Rolling Thunder®, Inc. Membership Patches and Obligations National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. A \$50.00 patch deposit is required before National will issue the Boot Patch.



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, which is the property of National. A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.

# **Membership Obligations**

**Retrieve Patches**: It's the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.

If you mail your patches to the Chapter, make sure you send the package **CERTIFIED** or **PRIORITY** mail for tracking purposes and insure the package for \$150.00.

Please DO NOT Glue your patches on your vest. National will NOT accept damaged patches and you may lose your patch refund.


