Red Skelton's recitation of the "Pledge of Allegiance" was twice read into the Congressional Record of the United States and received numerous awards.

I----meaning me, an individual, a committee of one.

**Pledge---**-dedicate all of my worldly goods to give without self-pity.

Allegiance----my love and my devotion.

To the Flag----our standard, Old Glory, a symbol of freedom. Wherever she waves, there is respect because your loyalty has given her a dignity that shouts freedom is everybody's job.

Of the United----that means that we have all come together.

**States**----individual communities that have united into 50 great states. 50 individual communities with pride and dignity and purpose, all divided with imaginary boundaries, yet united to a common cause, and that's love of country.

#### Of America.

And to the Republic----a republic, a state in which sovereign power is invested in representatives chosen by the people to govern. And government is the people and it's from the people to the leaders, not from the leaders to the people.

#### For which it stands!

One nation----meaning, so blessed by God.

Indivisible----incapable of being divided.

With Liberty----which is freedom and the right of power to live one's life without threats or fear or any sort of retaliation.

**And justice---**The principle and quality of dealing fairly with others.

For all ----which means, boys and girls, it's as much your country as it is mine.

### The Flame of Freedom Ceremony







Flame of Freedom Ceremony

The Flame of Freedom represents Light and Hope in knowing that someone is always there waiting to open the doors home.

Caring the Flame is John Wertz, Grandson of Chief Warrant Officer John William Frederick, Jr United States Marine Corps, who was held as a Prisoner of War in North Vietnam from December 7, 1965 until his death in captivity on or about July 19, 1972.

For hundreds of years the light in the distance meant hope. The flickering in the distance of the light high atop the lighthouse tells of nearing land in a heavy fog, the dim light of a front porch says come inside to the warmth of home, and let us not forget the lantern of Paul Revere riding through the streets to warn the British were coming.

There was a time long ago that our forefathers fought to provide us with freedom, then came other wars fought to preserve those freedoms.

Today, we fight to protect that freedom. This flame is also a symbol. It lights the way home for your brothers and sisters in arms. It crosses this great country to tell everyone the War-Fighter stands with pride and honor to keep us free and we keep the light burning to show the way home.

The light does not cast a shadow, for its sole purpose is to send the message of hope, to let everyone know that we will not forget. The table that sits before you, is a symbolism of faith and hope. A place waiting undisturbed until the War-Fighter returns home. The flame will light this table as long as the table sits empty.

### **The Missing Man Table Ceremony**

The Chapter Honor Guard team performed the Missing Man Table ceremony. The Missing Man Table ceremony is our way of recognizing those who remain missing. They may be still lying on the battle field, or they may be in the hands of our enemies, we don't know, they are Unaccounted-For.

Their remains have not been recovered, their whereabouts are unknown, and their fate is yet to be determined. These American heroes are Prisoner of War (POW) or Missing in Action (MIA).

They are not able to be with their loved ones, so we join together to pay humble tribute to them and to bear witness to their continued absence. The table is a physical symbol of the 81,000 American Service Members that are still listed as Unaccounted-For Nationwide since WWII. Indiana alone has 1,499 MIAs from WWII, 170 from the Korean War, and 51 from the Vietnam War.

The Honor Guard Team placed the covers for each branch of service on the table to symbolize their presents.

### The Meaning of the

### 13 Folds of the American Flag

### Here is the meaning of each of those folds:

The first fold of our flag is a symbol of life

The second fold is a symbol of our belief in eternal life

The third fold is made in honor and remembrance of all the veterans departing ranks who gave a portion of their lives for the defense of our country to attain peace throughout the world

The fourth fold represents our weaker nature, for as Americans citizens trusting in God, it is to Him we turn in times of peace as well as in time of war

The fifth fold is a tribute to our country, for in the words of Stephen Decature, "Our country, in dealing with other countries may she always be right: but it is still our country, right or wrong."

The sixth fold is for where our hearts lie. It is with our heart that we pledge allegiance to the flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with Liberty and Justice for all

The seventh fold is a tribute to our Armed Forces, for it is through the Armed Forces that we protect our country and our flag against all her enemies, whether they be found within or without boundaries of our republic

The eighth fold is a tribute to the one who entered into the valley of the shadow of death, that we might see the light of day, and honor mother, for whom it flies on Mother's Day

The ninth fold is a tribute to womanhood; for it has been through their faith, their love, loyalty and devotion that the character of the men and women who have made this country great has been molded

The tenth fold is a tribute to the father, for he, too, has given his sons and daughters for the defense of this country since they were first born

The eleventh fold, represents the lower portion of the seal of King David and King Solomon, and glorifies in the Hebrews eyes, the God of Abraham, Isaac, and Jacob

The twelfth fold, represents an emblem of eternity and glorifies in the Christian eyes, God the Father, the Son, and Holy Spirit

The thirteenth and final fold, when the flag is completely folded, the stars are uppermost reminding us of our nation's motto, "In God We Trust".

After the flag is completely folded and tucked in, it takes on the appearance of a cocked hat, ever reminding us of the soldiers who served under General George Washington, and the sailors and marines who served under Captain John Paul Jones, who were followed by the comrades and shipmates in the Armed Forces of the United States, preserving for us the rights, privileges, and freedoms we enjoy today.

The next time you see a flag ceremony honoring someone that has served our country, either in the Armed Forces or in our civilian services such as the Police Force or Fire Department, keep in mind all the important reasons behind each and every movement. They have paid the ultimate sacrifice for all of us by honoring our flag and our country.

### 2023 Chapter Member of the Year Award

The Chapter has several members that fall into this category, but unfortunately, we can only vote for one member.

Be prepared to tell the membership why you think your nominee should receive their vote.

The nominee must be a Member in Good Standing.

### Eli Lilly's American Civil War Service

In 1861, a few months after the start of the American Civil War, Lilly enlisted in the Union Army and joined the 21st Indiana Infantry Regiment on July 24. Lilly was commissioned as a second lieutenant on July 29, 1861. On August 3, the 21st Indiana reached Baltimore, Maryland, where it remained for several months. Lilly resigned his commission in December 1861 and returned to Indiana to form an artillery unit.

In early 1862 Lilly actively recruited volunteers for his unit among his classmates, friends, local merchants and farmers. He had recruitment posters created and posted them around Indianapolis, promising to form the "crack battery of Indiana". His unit, the 18th Battery, Indiana Light Artillery, was known as the Lilly Battery and consisted of six, three-inch ordinance rifles and 150 men. Lilly was commissioned as a captain in the unit. The 18th Indiana mustered into service at Camp Morton in Indianapolis on August 6, 1862, and spent a brief time drilling before it was sent into battle under Major General William

Rosecrans in Kentucky and Tennessee. Lilly's artillery unit was transferred to the Lightning Brigade, a mounted infantry under the command of Colonel, later General, John T. Wilder on December 16, 1862.

Lilly was elected to serve as the commanding officer of his battery from August 1862 until the winter of 1863, when his three-year enlistment expired. His only prior military experience had been in a Lafayette, Indiana, militia unit. Several of his artillerymen considered him too young and intemperate to command; however, despite his initial inexperience, Lilly became a competent artillery officer. His battery was instrumental in several battles, including the Battle of Hoover's Gap in June 1863 and in the Second Battle of Chattanooga and the Battle of Chickamauga in August and September 1863.

In 1864, when Lilly's term of enlistment ended, he resigned his commission and left the 18th Indiana. Lilly joined the 9th Indiana Cavalry (121st Regiment Indiana Volunteers) and was promoted to major. At the Battle of Sulphur Creek Trestle in Alabama in September 1864, he was captured by Confederate troops under the command of Major General Nathan B. Forrest and held in a **prisoner-of-war** camp at Enterprise, Mississippi until his release in a prisoner exchange in January 1865.

Lilly was promoted to colonel on June 4, 1865, and was stationed at Vicksburg, Mississippi, in the spring of 1865 when the war ended. In recognition of his service, he was brevetted to the rank of lieutenant colonel and mustered out of service with the 9th Indiana Cavalry on August 25, 1865.

In later life Lilly obtained a large atlas and marked the path of his movements in the war and the location of battles and skirmishes. He often used the atlas when telling war stories. His colonel's title stayed with him for the rest of his life, and his friends and family used it as a nickname for him. Lilly served as chairman of the Grand Army of the Republic, a brotherhood of Union Civil War veterans, in 1893. During his term he helped organize an event that brought tens of thousands of Union war veterans, including Lilly's battery, together in Indianapolis for a reunion and a large parade.

### **Chapter Events**: 87

The Chapter completed approximately 87 events in 2023 to include Chapter meetings. Some events were well attended and others would have made a bigger statement with more members in attendance. Some of the significant events included:

May 28th - Rolling Thunder® XXXV Ride for Freedom. This event took place at the Veterans National Shrine and Museum in Fort Wayne Indiana. We had approximately 36 members and 31 guest. The event went very well and we plan on returning to the Veterans National Shrine and Museum in 2024.

June 20-25 - Vietnam Veterans Memorial Traveling Wall. The Vietnam Veterans traveling wall came to Lawrence Indiana. Chapter members were involved in assisting the setup, guarding, and tearing down of he wall. The Chapter also performed our Roll Call ceremony at the opening ceremony.

**July 30th - 8th Annual USS Indianapolis Honor Watch**. Chapter Members were invited to read the names of the 31 Hoosier heroes who served on the USS Indianapolis, and gave the ultimate sacrifice when the USS Indianapolis was torpedoed by the Japanese on July 30th 1945. On that day, 879 men were killed in action and lost at sea.

**September 7th - Michigan Trip to Escort Veterans Remains**. Nine Chapter members rode to Jackson Michigan to assist in escorting the unclaimed remains of five Veterans from Jackson Michigan to Fort Custer Michigan. Upon arrival at Fort Custer, all five Veterans were buried with full Military Honors.

September 14th - Watch Fire Ceremony. Chapter Members assisted the Indianapolis POW/MIA Council with executing the Watch Fire Ceremony at the Indiana War Memorial (IWM). The ceremony started with youth groups placing 1,723 American Flags on the lawn of the IWM. After the placement of the flags, the groups moved into the IWM. The youths were broken down into groups and guided through the IWM to each historical display station. Once they arrived at each station, a docent brief the group with historical facts about the displays. When the youths arrived at the Pershing Auditorium, they would read the names of the 1723 Indiana MIAs that are still missing since WWII.

September 15th - POW/MIA Recognition Day and Escort. The POW/MIA Recognition Day Escort and Ceremony is an annual event that occurs on the third Friday in September. The Chapter was honored this year to escort seven MIA families from the Fort Harrison Veterans Center to the Indiana War Memorial for their POW/MIA Recognition Day Ceremony. The keynote speaker was Porter Halyburton. Porter was Shot down North East of Hanoi Vietnam in October 1965 and was a POW until his release during Operation Homecoming in 1973. The Chapter was honored to have Porter attend our September 17th Chapter meeting to brief the membership on his Military service and time as a POW.

**Sponsorship/Fund Raising** - Sponsorship and Fund Raising is an important part of the financial health of the Chapter. The Chapter would not be able to do our mission without funding. Due to the hard work of Chapter members going out and getting sponsors and donations, the Chapter collected \$18,471 in monetary and in-kind donations for 2023. Special thanks to all of our Sponsors and Chapter members that helped in collecting donations.

<u>Supporting our Veterans and their families</u> - The Chapter worked hard in supporting our Veterans in 2023 in many ways.

- 1. Indiana POW/MIA License Plate: The Indiana POW/MIA License Plate is a special tool that has two purposes. First, the POW/MIA License Plate helps bring awareness to the public about our POWs and MIAs, Secondly, the funds generated from the plate helps our Indiana Veterans in need. As of December 31st there are 4,830 POW/MIA License plates on the streets of Indiana. In 2023, the plate has generated \$119,600 dollars to help our Indiana Veterans through the Indiana Military Family Relief Fund. We have sold/renewed 38 more plates in 2023 compared to 2022. See charts on pages 24 and 25.
- 2. BINGO at the Indiana Veterans Home: Every year the Chapter plays BINGO with our Veterans at the Indiana Veterans Home in Lafayette Indiana. The Chapter made sure that every Veteran that played BINGO with the Chapter walk away with money in their pocket. In 2023, the Chapter paid out \$1,910 to the Veterans.
- 3. Wheelchair Ramp for Mary Nicholson, Covington Indiana: Mary is the widow of an Air National Guardsman who served for 8 year. Mary had to have her leg amputated due to an infection and is completely wheelchair bound. Mary lives with her daughter and the home doesn't have a ramp for easy access. The Chapter had a wheel chair ramp built for Many to help improve her quality of life.
- 4. **Wheelchair Ramp for Sandra Rigdon, Brazil Indiana**: Sandra is the Daughter of Seaman 1st Class Eldridge Wayne Bowles. Seaman Bowes reported for duty aboard the USS Indianapolis on October 8, 1943. Seaman Bowles was one of 879 men that was killed or lost at sea when the Japanese sank the USS Indianapolis on July 30th, 1945. Eldridge was 31 years old when he was lost sea.

Sandra's husband Clyde used a wheelchair to get around and had a difficult time getting in and out of their home with the wheelchair. The Chapter hired a contractor to build the wheelchair ramp for Clyde to help improve his quality of life.

- 5. Christmas Gifts for HVAF Veterans: In 2023, the Chapter purchased Christmas Gifts for 4 HVAF Veterans. The gifts included Thermo underwear, T-shirts, Ear muffs, sock hats, Socks, Convenience kits, gloves and other needed items. The total amount for the gifts was \$682.03.
- 6. **Pets Healing Vets**: The Pets Healing Vets program is an important program for our Veterans that suffer from PTSD and other issues. A K9 buddy helps the Veteran to cope with daily challenges. The Chapter made a \$500 donation to the Pets Healing Vets program at the March Chapter meeting and an addition \$500 at our October Chapter meeting for a total of \$1,000.
- 7. **Indy Honor Flights**: The Chapter has participated in the Welcome Home Celebrations for the Veterans returning home after visiting their monuments in Washington DC. Chapter members greeted Veterans at the Indianapolis Airport as they debark their airplane and at the Welcome Home celebration at the Plainfield High School. The Chapter donated \$500 to the Indy Honor Flight program.

This is a \$1,000 scholarship to be awarded to a Covington Community High School graduating senior seeking a higher education at an accredited College, University, or Trade School. The topic for the 2023 scholarship was "The Geneva Conventions as they relate to Prisoners of War (POWs).". The Chapter received one application for this scholarship. Micah Stonechipher of Covington Indiana submitted her application and was awarded the \$1,000 scholarship. Micah will continue her education at to Purdue University.
- 2. Chapter Scholarship. This is a \$1,000 scholarship to be awarded to a high school graduating senior or a student receiving the GED seeking a higher education at an accredited college, university, or trade school. The topic for the scholarship is the same at the Linda Smith-Cope scholarship. The applicant for this scholarship must be a resident of Indiana, and have a verifiable family relationship to a former Prisoner of War (POW) or Missing in Action (MIA). The purpose of this scholarship is to give back to the families that have sacrificed the lost of a loved one in war that remains unaccounted-for. The Chapter received two applications for this scholarship. Sydney Groves of Yorktown Indiana and Emily Brechenser of South Bend Indiana. Sydney is the great-niece of Michael Lautzenheiser who one of our Indiana 51 missing from the Vietnam War. Emily is the granddaughter of William Brechenser who was a POW during WWII.

Both Sydney and Emily did such a good job on the essay that the Scholarship committee awarded both students the \$1,000 scholarship. Sydney will continue her education at Ball State University and Emily will continue her education at Indiana University.

The previous pages are just a few of the Chapter accomplishments in 2023. We have many more things to accomplish in 2024 and we need your membership to continue on with our POW/MIA mission and helping our Indiana Veterans. Your membership is important, and we hope that you will continue your membership with the Chapter and help recruit new members.


### **Board/Chapter Meeting and Chili Cook-off**

You have from now until the February Chapter meeting to tweak your Chili recipe.


The Board meeting will be from 11:00 to 12:45 (**Board members only**) and the Chapter meeting will start at 13:00, everyone welcome.

## Indiana POW/MIA Specialty Plates on the Streets As of December 31, 2023



As of December 31, 2023, we have 4,830 POW/MIA specialty plates on the streets of Indiana helping to bring awareness to the public about our POWs, and MIAs. The funds generated from the sale of the POW/MIA Specialty plate goes towards helping our Indiana Veterans in need through the Indiana Military Family Relief Fund (MFRF). 215 plates were Renewed/Sold in December 2023. We have sold/renewed 38 more plates in 2023 compared to 2022.

## Indiana POW/MIA Specialty Plate Fund From 2010 to 2023



Since the introduction of the Indiana POW/MIA Specialty Plate in January 2010, the plate has generated an estimated \$1,299,675. 100% of the proceeds generated from the sales of the POW/MIA specialty plate goes to the Indiana Military Family Relief Fund (MFRF) to help our Indiana Veterans in need.

### **Chapter Scholarship Program**





The Chapter is giving back to the family members of our Indiana heroes by offering a \$1,000 scholarship to a high school senior or student receiving the GED, seeking a higher education at an accredited college, university, or trade school. This scholarship opportunity is only available to family members that are residents of Indiana and have a verifiable family relationship to a former POW or MIA.

The Chapter Scholarship started in 2021 and has help four of our MIA families in continuing their education to better their lives. The Chapter has generously donated \$4,000 in Scholarship funds to our MIA family members since 2021.

To be eligible for this Scholarship, the applicant must be a resident of Indiana and have a verifiable familial relationship to a former Prisoner of War (POW) or Missing in Action (MIA). The student applying for the scholarship will be required to independently write an essay on a POW/MIA themed topic of their choosing. The theme of the essay should be original and based on an event, person, philosophy or ideal.

Possible topic themes might be a discussion of POWs during a particular war (Revolutionary War, Civil War, WWI, etc.), POW encampments such as in Andersonville, Georgia, Camp Atterbury, Camp Morton, internment camps of Japanese-Americans during WWII.

The deadline for application submission is **April 30**, **2024**. Winner announcement and scholarship award will be made by June 30, 2024.

## Rolling Thunder®, Inc. Membership Patches and Obligations National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. A \$50.00 patch deposit is required before National will issue the Boot Patch.



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, which is the property of National. A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.

### **Membership Obligations**

**Retrieve Patches**: It's the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.

If you mail your patches to the Chapter, make sure you send the package **CERTIFIED** or **PRIORITY** mail for tracking purposes and insure the package for \$150.00.

Please DO NOT Glue your patches on your vest. National will NOT accept damaged patches and you may lose your patch refund.

### WWII MIA 2nd Lieutenant Gene F. Walker Richmond Indiana



On July 21, 2023, the Defense POW/MIA Accounting Agency (DPAA) identified the remains of Second Lieutenant Gene F. Walker, missing from World War II.

Second Lieutenant Walker entered the U.S. Army from Indiana and served in Company H, 3rd Battalion, 32nd Armored Regiment, 3rd Armored Division. This unit fought in Battle of the Hürtgen Forest, one of the bloodiest engagements of World War II. Between September 1944 and February 1945, the battle grew to involve approximately 200,000 troops, with tens of thousands of casualties on both sides. On November 24, 1944, 2LT Walker was killed when his tank was hit by enemy fire at Hücheln, Germany. According to witnesses, the vehicle caught fire, preventing recovery of his remains during the ongoing combat in the area. On December 3, an unknown set of remains was buried in an American military cemetery. Records from the time indicated that the remains belonged to a member of 2LT Walker's unit, but no recovery location was recorded. In August 2021, the Department of Defense and the American battle Monuments Commission exhumed these remains and sent them to a DPAA laboratory for further study. The laboratory analysis and the totality of the circumstantial evidence available established that the remains were those of 2LT Walker. 2LT Walker is expected to be buried in San Diego in early 2024.

With the identification of 2LT Walker, Indiana still has 1,499 missing from WWII.


