Rolling Thunder® Indiana Chapter 1 Elections

The June Chapter meeting was the start of our 2023 election cycle.

In accordance with the National Constitution, all members will be duly notified of elections by an announcement at the June, July and August Chapter meeting. **Nominations will be taken at our July and August Chapter meetings only.** You MUST be present to accept the Nomination.

To be nominated and/or elected for any officer position, a member must be in good standing for a period of (1) year or longer.

The member must have their Rocker/Eagle patches and have attended six (6) Chapter meetings in the past (12) months prior to nomination.

The election will be held at our September 17th Chapter Meeting.

The positions that will be up for election is the President, Secretary, (3) Board Members, and Alternate Board Member.

In accordance with the National Constitution, to be eligible for position of Chapter President, a member must have held a Chapter Executive Officer position or been a member of the Board of Directors for 12 months of a Chapter prior to being nominated. Under special circumstances a waiver may be granted by National.

In accordance with Chapter Rules Version 1.2, Any Chapter member in good standing wishing to run for the office of President, or Chairman of the Board, must first have held another office, i.e.: Treasurer, Secretary, or Board member, for a full term with RTIN Chapter #1.

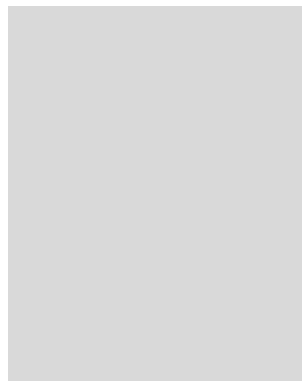

Chapter President Duties and Responsibilities Description

The Chapter President is an elected official with a (2) year term and is the Chief Executive Officer in charge of the daily operation of the Chapter. The Chapter President enhances the organization's public standing by clearly articulating the Rolling Thunder® mission statement, accomplishments, and goals to the public and garners support from the community.

The duties of the Chapter President will include, but not limited to the following duties.

- a. Responsible for the overall day-to-day operation, safety, management and financial order of the organization.
- b. The Chapter President ensures that all officers, board members and members follow the Constitution.
- c. The Chapter President sets the agenda and runs the monthly membership meetings and ensures all meetings are run according to the Constitution and Roberts Rules when applicable.
- d. The Chapter President gives agenda ideas for discussion to the Chairman of the Board for the Board Meetings. (The Chairman of the Board runs the Board Meeting).
- e. Must have held another office, i.e.: Treasure, Secretary, or Board member, for a full term with Indiana Chapter #1.
- f. Must not miss (3) consecutive meetings without legitimate excuse.
- g. The President is responsible to the Vice President of Rolling Thunder® Inc. National. In some cases, through the State Liaison, if in the chain of command.

Chapter Secretary Duties and Responsibilities Description

The Chapter Secretary is an elected official with a (2) year term. The Chapter Secretary attends and records the minutes of all meetings and is the records officer for the Chapter. The Chapter Secretary enhances the organization's public standing by clearly articulating the Rolling Thunder mission statement, accomplishments, and goals to the public and garners support from the community.

The duties of the Chapter Secretary will include, but not limited to the following duties.

- a. Recording, editing and maintaining all meeting minutes
- b. Maintains custody of all records, reports on behalf of the executive officers.
- c. Prepares and distributes all incoming/outgoing correspondences, memorandums etc.
- d. Assist in the preparation of the Organizational Activities Reports.
- e. Provides monthly minutes to the Chapter for review.
- f. Must not miss (3) consecutive meetings without legitimate excuse submitted to the Chapter President.
- g. The Secretary is responsible to the President of the Chapter.
- h. Have a working knowledge of the National Constitution and Chapter Rules found on the Rolling Thunder® Indiana Chapter 1 website.

Chapter Board Member Duties and Responsibilities Description

The Chapter Board Member is an elected official with a (2) year term. The Chapter Board Member enhances the organization's public standing by clearly articulating the Rolling Thunder® mission statement, accomplishments, and goals to the public and garners support from the community.

Chapter Alternate Board Member Duties and Responsibilities Description

The Chapter Alternate Board Member is an elected official with a (2) year term. The Alternate Board Member enhances the organization's public standing by clearly articulating the Rolling Thunder® mission statement, accomplishments, and goals to the public and garners support from the community.

The duties of the Alternate Board Member will include, but not limited to the following duties.

- a. Reports to the Chairman of the Board.
- b. Must attend all scheduled Board meetings and special Board meetings as determined by the Chairman of the Board or Chapter President.
- c. Must not miss (3) consecutive meetings without legitimate excuse submitted to the Chairman of the Board or Chapter President.

The Vietnam Veterans Memorial Moving Wall June 22nd to June 25th

The Vietnam Veterans Memorial Moving Wall came to Lawrence Indiana in the month of June. On June 22nd, volunteers started to mount the wall on the base that was constructed a few day prior to the wall arriving in Lawrence. After a few hours of driving stakes and bolting the wall together, the project was completed.

The following day, visitors came to visit the wall. Family members and friends would drop by the information table to look up the names of loved ones and friends who's name is on the wall. Once they new the panel and line number, they would go to the wall to see the name of their loved one or friend listed on the wall. Some of the family members would leave artifacts at the base of the wall in remembrance of their loved one.

The moving wall is a 1/2 replica of the Vietnam Veterans Memorial Wall in Washington DC. The wall currently has 58,318 names on the wall. Of the 58,318 names listed on the wall, 1,534 are Indiana Hoosiers to include 1 woman from Lafayette Indiana, CPT Mary T. Klinker, United States Airforce.

The names listed on the wall are 100% identical to the names listed on the Vietnam Veterans Memorial Wall in Washington DC. If a name is spelled incorrectly on the wall in Washington DC., the name has to be spelt incorrectly on the moving wall. If a name is added to the wall in Washington DC, the name will have to be added to the moving wall.

After the wall was put together, volunteers from the Chapter and other organizations guarded the wall around the clock taken 4 hour shifts. The guards would assist visitors that arrived late a night with looking up names and showing them how to find the name on the wall. The others duties included protecting the wall to make sure it remains safe while on display.

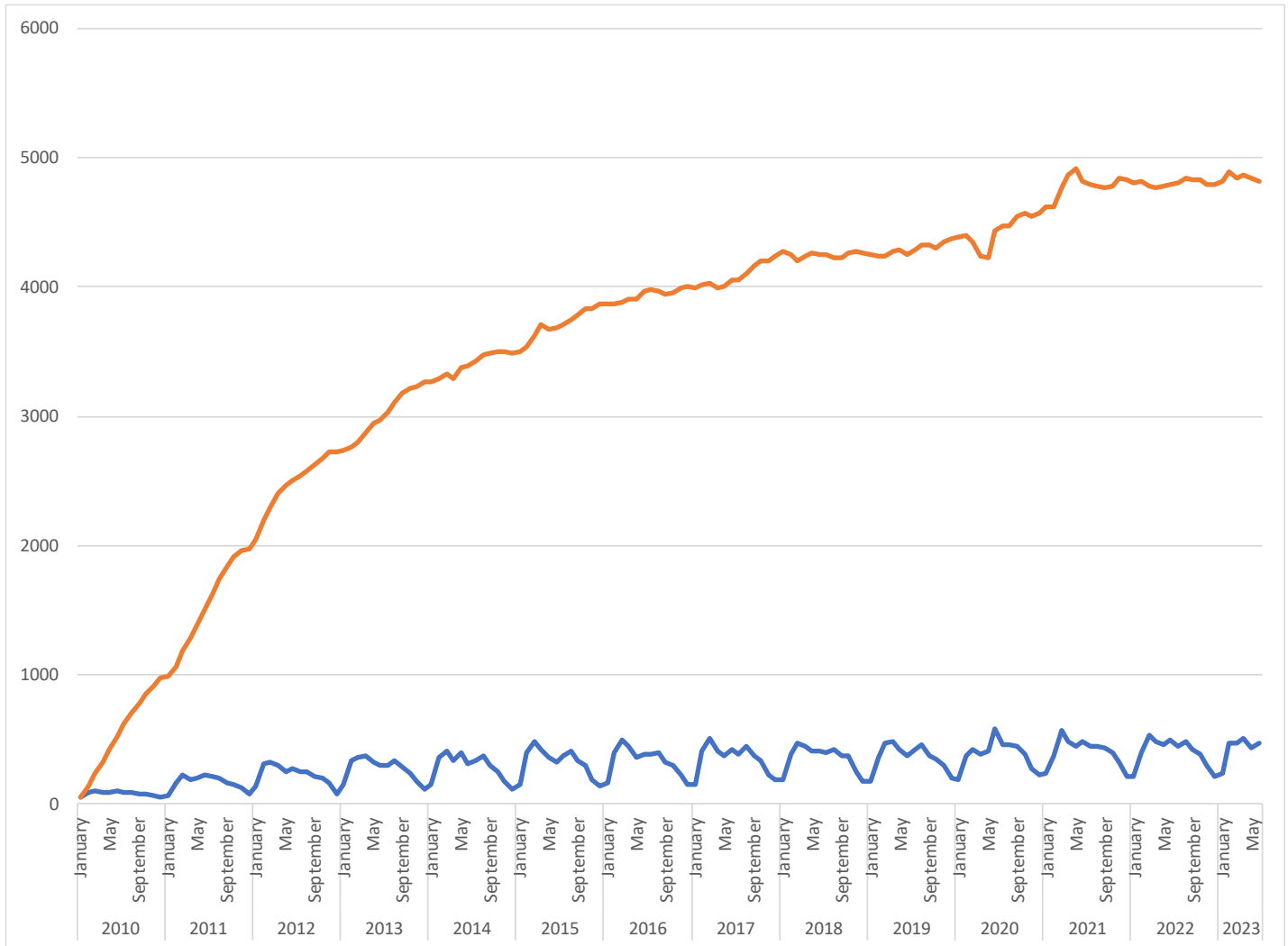

Indiana POW/MIA Specialty Plates on the Streets

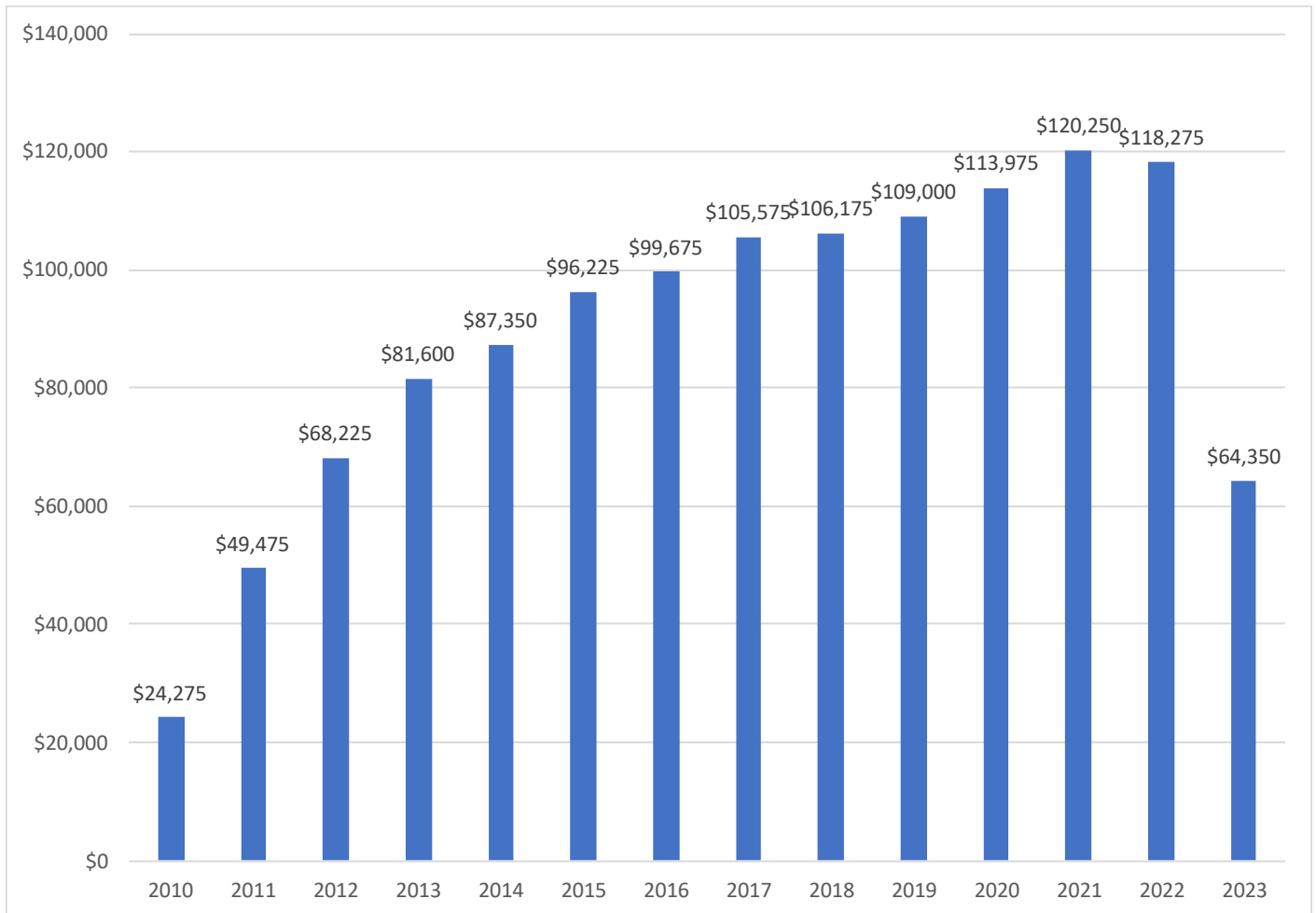
As of June 30, 2023



As of June 2023, we have **4,816** POW/MIA specialty plates on the streets of Indiana helping to bring awareness to the public about our POWs, and MIAs. The funds generated from the sale of the POW/MIA Specialty plate goes towards helping our Indiana Veterans in need through the Indiana Military Family Relief Fund (MFRF). **We are 19 plates up from this time last year.**

Since the introduction of the Indiana POW/MIA Specialty Plate in January 2010, the plate has generated an estimated **\$1,244,425** 100% of the proceeds generated from the sales of the POW/MIA specialty plate goes to the Indiana Military Family Relief Fund (MFRF) to help our Indiana Veterans in need.

Rolling Thunder® , Inc. Membership Patches and Obligations

National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. **A \$50.00 patch deposit is required before National will issue the Boot Patch.**



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, **which is the property of National.** **A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.**

Membership Obligations

Retrieve Patches: It's the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. **The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.**

If you mail your patches to the Chapter, make sure you send the package CERTIFIED or PRIORITY mail for tracking purposes and insure the package for \$150.00.

Please DO NOT Glue your patches on your vest. National will NOT accept damaged patches and you may lose your patch refund.
