## Fallen IMPD Officer Breann Leath

1995 - 2020



The Chapter has been invited to attend the Scholarship presentation to Zayne Bartolome, the son of Officer, Breann Leath who was killed in the line of duty on April 9, 2020.

### **Officer Leath's story:**

Police were called to the Harrison Terrace apartments in the 1800 block of Edinburgh Square, which is just southwest of 21st Street and North Franklin Road, around 2:50 p.m. for a domestic disturbance. Officer Breann Leath, 24, was responding to a domestic incident at an apartment at 1803 Edinburgh Square when she was shot.

Officers were called to the apartment for a domestic incident, IMPD Assistant Chief Chris Bailey said. When they arrived, shots were fired and the officer and a female inside the apartment were shot. They were both rushed to the hospital. Officer Breann Leath died at the hospital. She was 24 years old and a graduate of Southport High School.

# Linda J. Smith-Cope Memorial Ride to the Wall

July 21-26, 2022



Linda was a member of Indiana Chapter One from 2006 to her unexpected passing in 2019. After returning home from the 2019 Ride for Freedom Demonstration, Linda went in for an outpatient surgery and developed a bacterial skin infection that rapidly spread through her entire body. She endured 2 post surgeries to reverse the infection, tons of antibiotics and a borage of other stuff to help save her life. The doctors were not able to stop the infection and she passed on June 11, 2019.

Linda is the sister of SFC Ronald Eugene Smith, which went missing in 1970 and still listed as one of our Indiana MIAs from the Vietnam War. Linda and her family has made several trips with the Chapter to Washington D.C to visit her Brother Ron who is listed on the Vietnam Memorial Wall.

Due to COVID concerns, the Chapter was not able to do a memorial ride for Linda in 2020 or 2021. We are hoping that COVID will not be a major concern this year. The memorial ride will include a visual at the Vietnam Memorial Wall in Washington D.C, a visit to Gettysburg, PA and Flight 93 National Memorial in Shanksville, PA. **Tuesday July 26th** - Depart to Indianapolis, IN

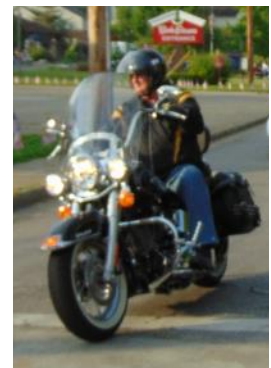

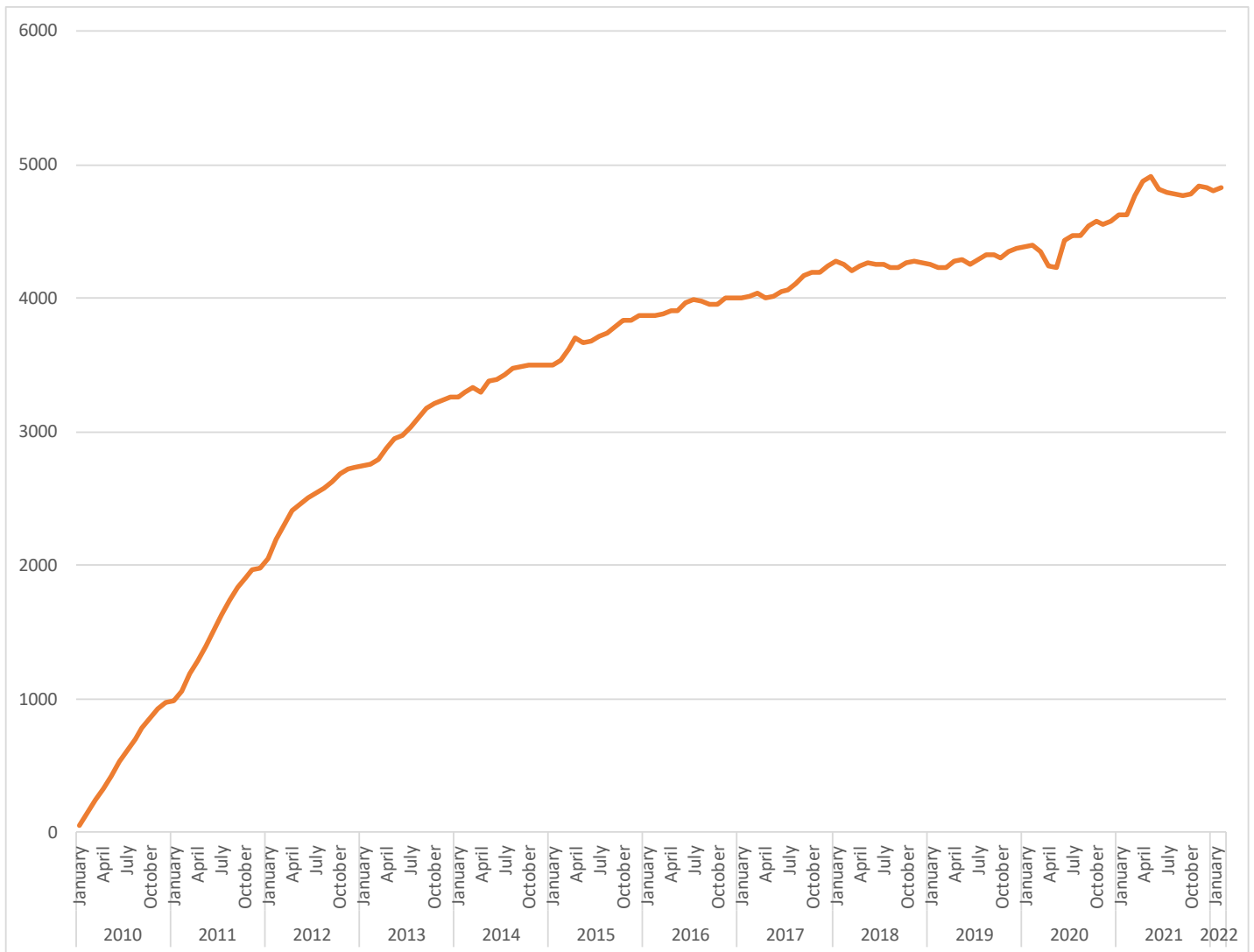
## Majestic Stone Imports Presentation

# Indiana POW/MIA Specialty Plates

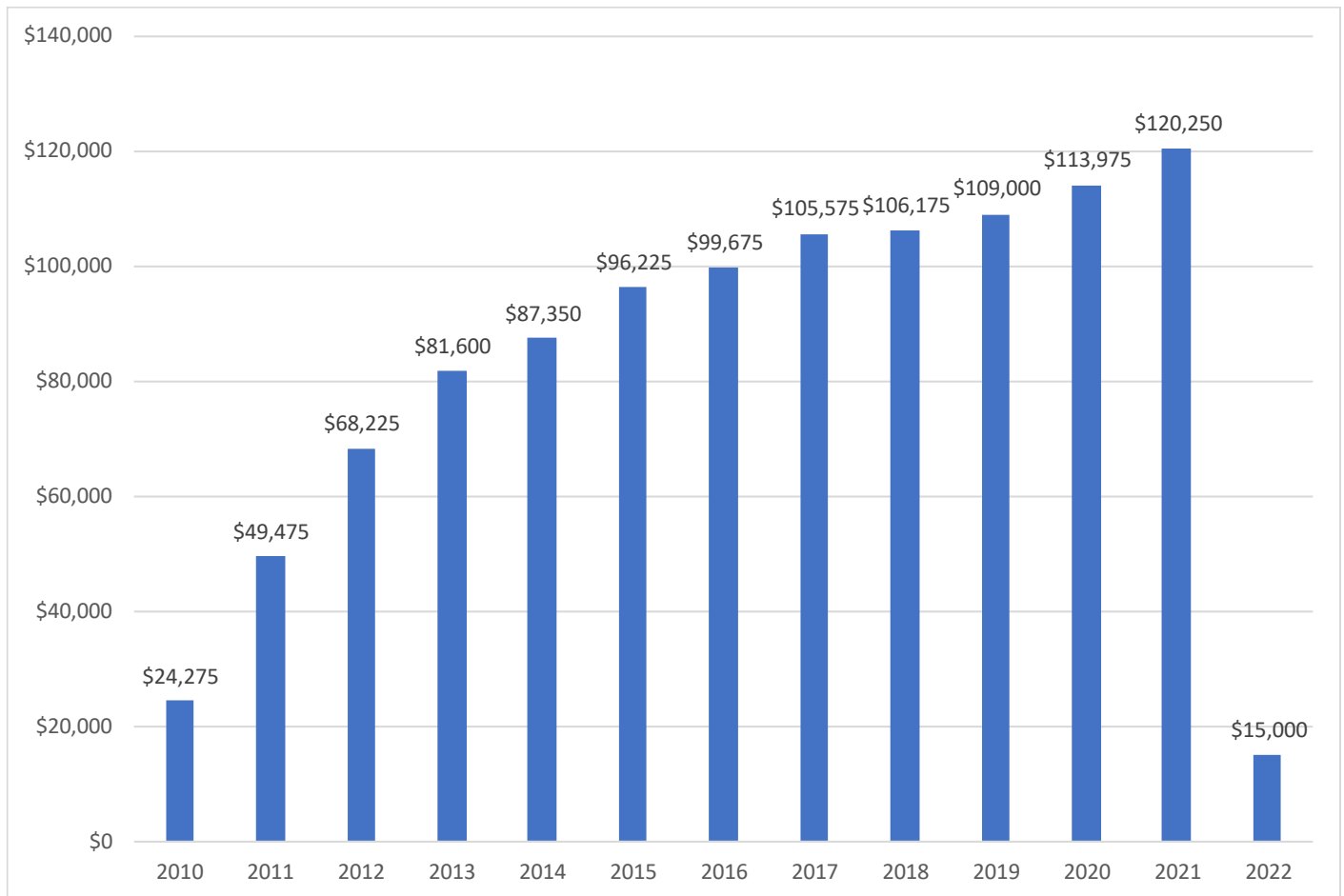
## As of February 28, 2022

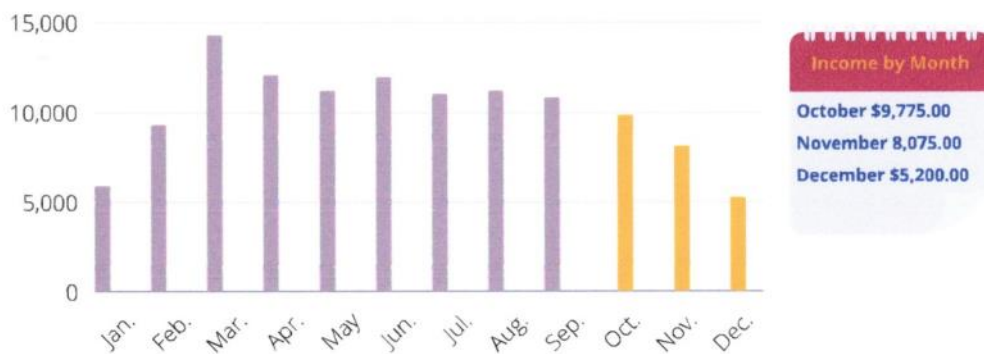

**2021 Q4 Total Rolling Thunder/MFRF Expenditures: \$22,922.89**

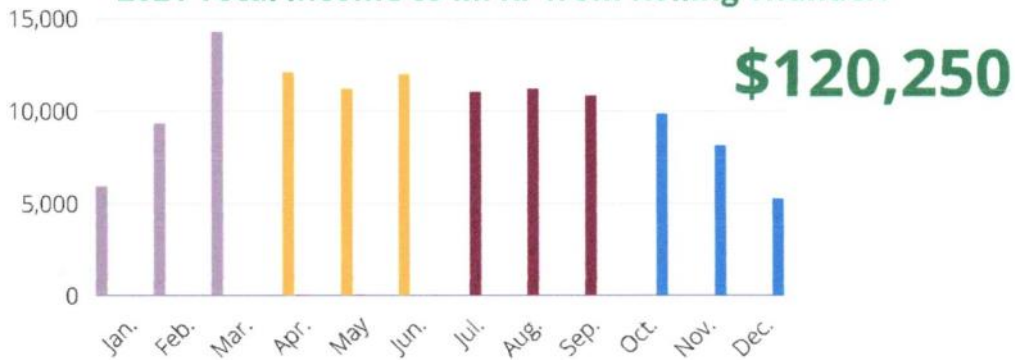

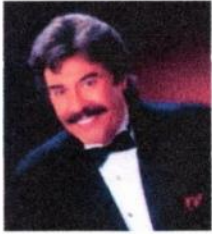

## Tie a Yellow Ribbon

The man's voice on the other end of the line was familiar. Still, Tony Orlando thought it was a joke when the man said, "Tony, this is Bob Yellow Ribbon Hope."

"This is Frank I-don't-believe-you Sinatra," Orlando shot back.



It was the spring of 1973, and the group "Tony Orland and Dawn" had just released a song about a guy who was returning home by bus after "three long years" away. Would his love still want him? The guy asked the bus driver. Would she tie a yellow ribbon 'round the old oak tree to show him she wanted him home?



Bob Hope was arguably the most famous comedian in America then, and he had made scores of USO trips to entertain the troops during World War II, the Korean War, and the Vietnam War. He wanted Orlando to sing "Tie a Yellow Ribbon" at the Cotton Bowl, at a performance to welcome home American prisoners of war from Vietnam, Laos, and Cambodia. "That line from your song – 'I'm coming home, I've done my time' – is perfect to open the show," Hope said.

"I don't want to disappoint you," Orlando answered, "but no one knows that song."

And Hope replied: "By the time you come down to the Cotton Bowl, that song will be No. 1." And two weeks later it was. Eventually, in fact, it was the Billboard #1 song of 1973.

There were 70,000 people in the audience at the Cotton Bowl that April. "I see Bob Hope smiling at me with a big wink," Orlando remembers. "We finish the song and there was one former POW on the front row who wasn't getting into the song, wasn't clapping. I asked Bob Hope, 'Do you think I offended him?' And he said, 'Go ask him.'" So Orlando did.

The POW apologized. "I'm sorry," he said. "My shoulders have been pulled out and I can't clap, but what you can't see is my big toe tapping along." The former POW introduced himself: "I'm John McCain."

When Orlando performed that year at the Copacabana, he flew 10 of the returned POWs to New York City, and convinced the management to dress up the nightclub with yellow ribbons. It was the start of 40 years of shows that have raised hundreds of millions of dollars for veterans' causes.

In 2013, on the 40<sup>th</sup> anniversary of the POWs homecoming, Orlando donated his "Tie a Yellow Ribbon" gold record to the Nixon Presidential Library and Museum. By then, yellow ribbons had become symbols of hope and homecoming for every Soldier who goes off to war.

**2d Lt. Audie Murphy**  
**WWII Medal of Honor Recipient**



Audie L. Murphy, born in Hunt County, Texas, earned the Medal of Honor for his heroism during the Battle of Colmar Pocket in Holtzwihr, France.

**Medal of Honor Citation:**

"2d Lt. Murphy commanded Company B, which was attacked by 6 tanks and waves of infantry. 2d Lt. Murphy ordered his men to withdraw to prepared positions in a woods, while he remained forward at his command post and continued to give fire directions to the artillery by telephone. Behind him, to his right, 1 of our tank destroyers received a direct hit and began to burn. Its crew withdrew to the woods. 2d Lt. Murphy continued to direct artillery fire which killed large numbers of the advancing enemy infantry. With the enemy tanks abreast of his position, 2d Lt. Murphy climbed on the burning tank destroyer, which was in danger of blowing up at any moment, and employed its .50 caliber machinegun against the enemy. He was alone and exposed to German fire from 3 sides, but his deadly fire killed dozens of Germans and caused their infantry attack to waver. The enemy tanks, losing infantry support, began to fall back. For an hour the Germans tried every available weapon to eliminate 2d Lt. Murphy, but he continued to hold his position and wiped out a squad which was trying to creep up unnoticed on his right flank. Germans reached as close as 10 yards, only to be mowed down by his fire. He received a leg wound, but ignored it and continued the single-handed fight until his ammunition was exhausted. He then made his way to his company, refused medical attention, and organized the company in a counterattack which forced the Germans to withdraw. His directing of artillery fire wiped out many of the enemy; he killed or wounded about 50. 2d Lt. Murphy's indomitable courage and his refusal to give an inch of ground saved his company from possible encirclement and destruction, and enabled it to hold the woods which had been the enemy's objective."

## WWII MIA

**Flossie Delene Flannery**

**Mount Summit Indiana**

Flossie Delene Flannery was born on April 16, 1916. According to our records Indiana was her home or enlistment state and Henry County included within the archival record. We have Mount Summit listed as the city.



She was declared missing in action after the disappearance of the C-47B #44-76406 she was traveling on as passenger off the coast of Ghana. The plane was carrying 18 members of the Women's Army Corp WACS and was normally a routine flight from Accra, British West Africa to Liberia.

She was born in Kentucky, but spent most of her life in Mount Summit, Indiana, near Muncie.

She was one of 159 WACs who arrived in Accra in November 1944 to serve with the Air Transport Command. Created to deliver troops and supplies overseas, as well as to transfer aircraft to where the planes were most needed, Air Transport Command spanned the globe.

The WACs who were part of the 1202nd Army Air Force Base Unit were older than most other recruits, as they were "chosen for maturity and work experience." Their average age was 28 and they collectively represented wide and varied life experiences and professions.

# Rolling Thunder®, Inc. Membership Patches and Obligations

## National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



**The Chapter Boot Patch.** All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. **A \$50.00 patch deposit is required before National will issue the Boot Patch.**



**The Rocker and Eagle Patches.** After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing, they will be issued the Eagle & Rocker patches, **which is the property of National.** **A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.**

## Membership Obligations

**Retrieve Patches:** It is the Chapters responsibility to retrieve all patches. If a member does not re-new dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. **The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.**

**If you mail your patches to the Chapter, make sure you send the package CERTIFIED or PRIORITY mail for tracking purposes and insure the package for \$150.00.**
