Korean War MIA Accounted For



On June 5, 2020, the Defense POW/MIA Accounting Agency (DPAA) accounted for Corporal Stanley Lee DeWitt, missing from the Korean War. Corporal DeWitt, who entered the U.S. Army from Indiana, was a member of the Medical Detachment, 57th Field Artillery Battalion, 7th Infantry Division. His unit was a part of the 31st Regimental Combat Team (RCT), tasked with replacing the 5th Marine Regiment on the east side of the Chosin Reservoir, and arrived at the P'ungnyuri Inlet in late November 1950. Chinese Communist Forces (CCF) launched large-scale attacks against the 31st RCT through December 1, when the RCT withdrew to the town of Hagaru-ri at the base of the Chosin Reservoir. On December 6, at some point, CPL DeWitt was killed during the withdrawal but his remains were not recovered at the time of his loss, nor were they identified among those returned to U.S. custody after the war.

In 2018, U.S. President Trump and D.P.R.K. (North Korea) Chairman Kim Jong-un conducted a summit meeting in Singapore. Chairman Kim promised to repatriate American remains and turned over 55 boxes that were said to contain the remains of American service members killed in the Korean War. The remains were then transferred to the Defense POW/MIA Accounting Agency (DPAA) laboratory in Hawaii for identification purposes. Scientists used anthropological analysis and circumstantial evidence to identify Stanley's remains. Other scientists from the Armed Forces Medical Examiner System used mitochondrial DNA analysis. In layman's terms, the 54th box to be opened matched the DNA provided 20-years ago by the DeWitt brothers. Sgt. Stanley DeWitt was officially accounted for on June 5, 2020.

On Tuesday October 19th, Chapter members and the Indiana Patriot Guard escorted Sergeant DeWitt from the Indianapolis Airport to the funeral Chapel in Logansport, Indiana.

The Funeral Service for Sgt. Stanley Lee DeWitt was held on Saturday, October 23, 2021, at the Fisher Funeral Chapel in Logansport, Indiana. Rev. Carolyn DeWitt (whose husband, Wendell, was just ten-years-old when his Uncle Stanley went missing in action) officiated the service. After the funeral services, Sergeant DeWitt was escorted to his final resting place at the Royal Center Cemetery located Royal Center Indiana.

Lois spoke about the New Freedom Farm and the help that the farm has brought to Veterans. The farm is known for healing Veterans through horses. The New Freedom Farm mission is to provide a refuge and rehabilitation from trauma to veterans and first responders, and equines, including the American Mustang. The New Freedom farm has an annual Freedom fest which will take place April 9th and 10th, 2022. Several Rolling Thunder® Chapters throughout the States have paid a visit to the New Freedom Farm.









Rolling Thunder®, Inc National Conference November 4th through 7th, 2021 LTG McInerney



After graduating from USMA in June 1959, McInerney was commissioned as a second lieutenant in the United States Army. He then joined the Air Force, and completed initial pilot training at Bartow Air Base, Florida, and Laredo Air Force Base, Texas, in November 1960. He participated in the Berlin and Cuban crises in 1962, flying escort missions in the West Berlin Air Corridor and escort reconnaissance missions over Cuba during the Cuban Missile Crisis. In April 1963, he was one of the first forward air controllers assigned to South Vietnam with a Vietnamese army division. He participated in three additional Southeast Asia deployments.

After completing the Armed Forces Staff College in February 1970, he was transferred to the Directorate of Operational Requirements, Air Force headquarters. Upon graduation from National War College in July 1973, McInerney was assigned to the 58th Tactical Fighter Training Wing, Luke Air Force Base, as F-104 and F-5 director of operations. In August 1974, he became the air attaché to the U.S. Embassy in London. From November 1976 until October 1977, he was vice commander of the 20th Tactical Fighter Wing, Royal Air Force Station Upper Heyford, England. McInerney then became military assistant to Ambassador Robert W. Komer. In March 1979, McInerney became commander of the 3rd Tactical Fighter Wing, Clark Air Base, Philippines.

In February 1981, he became commander of the 313th Air Division, Kadena Air Base, Japan. McInerney then was deputy chief of staff for operations and intelligence, Headquarters Pacific Air Forces, Hickam Air Force Base, Hawaii, from June 1983 to July 1985, when he became commander of 3rd Air Force, Royal Air Force Station Mildenhall, England. In October 1986, McInerney was assigned as vice commander in chief, Headquarters U.S. Air Forces in Europe, Ramstein Air Base, West Germany. He became commander of Alaskan Air Command, Alaskan NORAD Region, and Joint Task Force Alaska in May 1988. McInerney assumed command of Alaskan Command upon its activation in July 1989 and became commander of 11th Air Force when Alaskan Air Command was redesignated 11th Air Force in August 1990.

McInerney's last active duty assignment was as assistant vice chief of staff, Headquarters U.S. Air Force, Washington, D.C. He retired from the Air Force on 1 July 1994. Upon his retirement, he kept his finger on the pulse of the intelligence community and national politics. He was a Military Analyst on Fox News from 2002 to 2018.

Art Foss was proud of his 27-year career in the U.S. Army, which included two tours of duty in Vietnam. Even after he retired from the Army, Art wanted to continue to serve the military families. With that in mind, in August 1999, Art became a Charter Member and the President of Rolling Thunder® Virginia Chapter 3. Art was dedicated to Never Forgetting the POW/MIAs and an advocate for the needs of today's military veterans and their families.

He diligently served as the Senior State Director for Rolling Thunder® Inc. and was instrumental in starting additional Chapters in Virginia and Maryland. Art was committed to bringing government awareness to our POW/MIAs and to educate the children and the public on the need to support our veterans.

Under Art's straight-forward, no-nonsense leadership of Rolling Thunder® VA Chapter 3 it raised funds and sponsored several veterans' events such as a Father's Day Cookout at McGuire VA Hospital in Richmond; Thanksgiving and Christmas food baskets for active duty military families; and "The Ride Home," which is a special weekend to honor all former Prisoners of War and remember those still Missing in Action.


New Members are Welcome

History of The Gadsden Flag Don't Tread on Me Flag



The bright yellow <u>Gadsden flag</u>, long a symbol of support for civil liberties and disagreement with government, has its beginning deeply rooted in the days of the American Revolution. The rattlesnake, the Gadsden flag's central feature, had been an emblem of Americans even before the Revolution. The Pennsylvania Gazette published an article in 1751 bitterly protesting the British practice of sending convicts to America where the author suggested that the colonists should return the favor by shipping them "a cargo of rattlesnakes." Three years later the same newspaper published what is believed to be one of the first political cartoons in America. It was of a snake cut into eight sections with the words "Join, or Die" below. Each section represented a colony and was warning of the dangers of disunity.

The rattlesnake symbol caught on and became a part of several other Revolutionary War flags. Before the departure of the United States Navy's first mission in 1775, Continental Colonel Christopher Gadsden from South Carolina presented the newly appointed commander with a yellow rattlesnake flag to serve as a standard for his flagship. Accompanying the Navy on its first mission were five companies of Marines carrying yellow drums featuring a snake with 13 rattles and the words "Don't Tread on Me." The Navy later adapted the snake emblem and "Don't Tread on Me" motto into what is now known as the First Navy Jack. Featuring a rattlesnake stretched across 13 red and white stripes with "Don't Tread on Me" below, the Secretary of the Navy ordered in 2002 that this powerful American symbol will fly on all naval ships for the duration of the War on Terrorism.

About the same time Gadsden presented the Congress of South Carolina with his yellow flag another variation of the snake theme was gaining in popularity. The <u>Culpeper flag</u>, the white banner carried by the Minutemen of Culpeper County, Virginia, is essentially the Gadsden flag with several additions. A ribbon with the words "The Culpeper Minute Men" was added along with the words "Liberty or Death" in honor of the man who organized the Virginia militia, Patrick Henry.

Although there have been several adaptations of the snake emblem, the Gadsden flag continues to be reintroduced as a symbol of defending freedom and the rule of law. Since 2009, the Gadsden flag has become associated with the American Tea Party Movement, as well as several other protest events. For historical reasons, the Gadsden is still popularly flown in Charleston, South Carolina, in tribute to the man who first presented the yellow snake flag.

In December 1775, "An American Guesser" anonymously wrote to the Pennsylvania Journal:

"I observed on one of the drums belonging to the marines now raising, there was painted a Rattle-Snake, with this modest motto under it, 'Don't tread on me.' As I know it is the custom to have some device on the arms of every country, I supposed this may have been intended for the arms of America."

This anonymous writer, having "nothing to do with public affairs" and "in order to divert an idle hour," speculated on why a snake might be chosen as a symbol for America.

First, it occurred to him that "the Rattle-Snake is found in no other quarter of the world besides America."

The rattlesnake also has sharp eyes, and "may therefore be esteemed an emblem of vigilance." Furthermore,

"She never begins an attack, nor, when once engaged, ever surrenders: She is therefore an emblem of magnanimity and true courage. ... she never wounds 'till she has generously given notice, even to her enemy, and cautioned him against the danger of treading on her."

Finally,

"I confess I was wholly at a loss what to make of the rattles, 'till I went back and counted them and found them just thirteen, exactly the number of the Colonies united in America; and I recollected too that this was the only part of the Snake which increased in numbers. ...

"Tis curious and amazing to observe how distinct and independent of each other the rattles of this animal are, and yet how firmly they are united together, so as never to be separated but by breaking them to pieces. One of those rattles singly, is incapable of producing sound, but the ringing of thirteen together, is sufficient to alarm the boldest man living."

Many scholars now agree that this "American Guesser" was Benjamin Franklin.

Rolling Thunder®, Inc. Membership Patches and Obligations National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



The Chapter Boot Patch. All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. A \$50.00 patch deposit is required before National will issue the Boot Patch.



The Rocker and Eagle Patches. After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing ,they will be issued the Eagle & Rocker patches, which is the property of National. A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.

Membership Obligations

Retrieve Patches: It is the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.

If you mail your patches to the Chapter, make sure you send the package **CERTIFIED** or **PRIORITY** mail for tracking purposes and insure the package for \$150.00.



Indiana POW/MIA Specialty Plates As of October 31, 2021




