**Sergeant Stanley Lee DeWitt**  
**Royal Center Indiana**  
**Korean War MIA Accounted For**



On June 5, 2020, the Defense POW/MIA Accounting Agency (DPAA) accounted for Corporal Stanley Lee DeWitt, missing from the Korean War. Corporal DeWitt, who entered the U.S. Army from Indiana, was a member of the Medical Detachment, 57th Field Artillery Battalion, 7th Infantry Division. His unit was a part of the 31st Regimental Combat Team (RCT), tasked with replacing the 5th Marine Regiment on the east side of the Chosin Reservoir, and arrived at the P'ungnyuri Inlet in late November 1950. Chinese Communist Forces (CCF) launched large-scale attacks against the 31st RCT through December 1, when the RCT withdrew to the town of Hagaru-ri at the base of the Chosin Reservoir. On December 6, at some point, CPL DeWitt was killed during the withdrawal but his remains were not recovered at the time of his loss, nor were they identified among those returned to U.S. custody after the war.

In 2018, U.S. President Trump and D.P.R.K. (North Korea) Chairman Kim Jong-un conducted a summit meeting in Singapore. Chairman Kim promised to repatriate American remains and turned over 55 boxes that were said to contain the remains of American service members killed in the Korean War. The remains were then transferred to the Defense POW/MIA Accounting Agency (DPAA) laboratory in Hawaii for identification purposes. Scientists used anthropological analysis and circumstantial evidence to identify Stanley's remains. Other scientists from the Armed Forces Medical Examiner System used mitochondrial DNA analysis. In layman's terms, the 54th box to be opened matched the DNA provided 20-years ago by the DeWitt brothers. Sgt. Stanley DeWitt was officially accounted for on June 5, 2020.

**A Funeral Service paying tribute to the life of Sgt. Stanley Lee DeWitt will be held at 2:00 p.m. Saturday, October 23, 2021, in Fisher Funeral Chapel, 1801 Chase Road, Logansport, Indiana.** Rev. Carolyn DeWitt (whose husband, Wendell, was just ten-years-old when his Uncle Stanley went missing in action) will officiate at the service. A public visitation will take place from noon to 2 p.m. prior to the service at the funeral chapel on Oct. 23rd. Following the service, the funeral procession will travel through downtown Logansport via Chase Road to Michigan Avenue to 6th Street then west on Broadway to West Market Street where the procession will eventually head north on U.S. Hwy. 35 towards the Royal Center Cemetery. Full military honors will be accorded by the U.S. Army. The Cass County Honor Guard will assist as the Color Guard. The Indiana Patriot Guard will provide a flag display and motorcycle escort to the cemetery. The public is encouraged to line the procession route on Saturday, Oct. 23rd, with a patriotic show of support as we bring this hero home to his place of rest.

Additional details on Sergeant DeWitt's return will be provided when known.

# Watchfire Ceremony

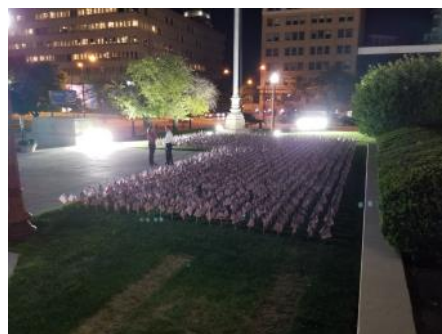
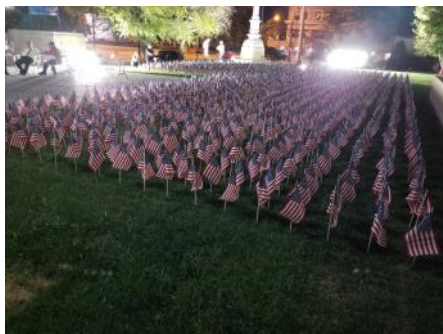
## Friday September 17, 2021

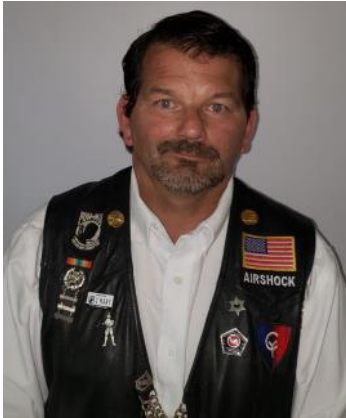
Nick Esposito has served as Alternate Board Member and Board Member over the past four years. His input to the Board has been instrumental in the Board making important decisions for the Chapter.

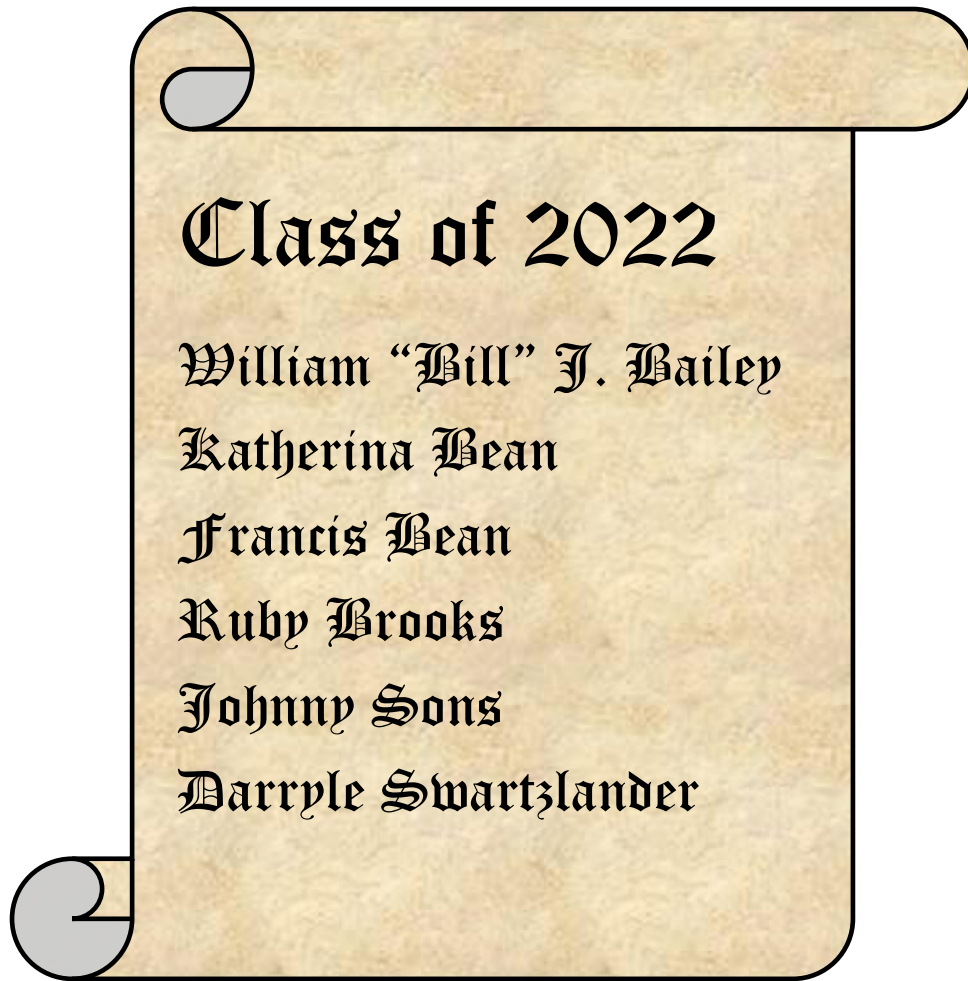

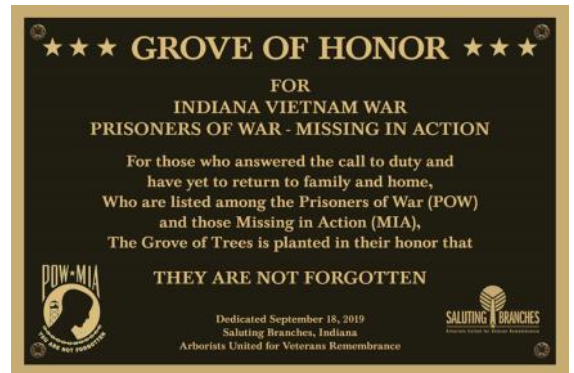
## POW\*MIA Grove of Honor Dedication Indiana Veterans Home, Lafayette IN September 22, 2021

## Constitution Grove Crane Indiana



**The U.S. Navy maintains a 50,000-acre white oak forest called "Constitution Grove" in the middle of Indiana for the sole purpose of refitting and restoring the USS Constitution, which is over 200 years old and is the oldest commissioned vessel still sailing.**

On May 8, 1976, CDR Tyrone G. Martin, Constitution's commanding officer, and H. Robert Freneau, Secretary of the Navy Special Assistant, dedicated the ceremonial "Constitution Grove" at Naval Support Activity (NSA) Crane, Indiana. One hundred and fifty white oak trees spread over the 64,000-acre base were designated for Constitution.

# Rolling Thunder®, Inc. Membership Patches and Obligations

## National Constitution

The Rolling Thunder® patches are items that members strive to obtain. The Boot patch represents the members Chapter, and the Rocker and Eagle represents Rolling Thunder® National. These patches should be worn proudly and with respect. When a member is issued these patches, they have an obligation to take care of them and turn them in if they decide to quit Rolling Thunder® for whatever reason. Below is an abstract from the National Constitution on the members obligations that they agree to when they receive these patches.



**The Chapter Boot Patch.** All members will receive a Rolling Thunder® Membership Boot patch when they become a full member at the end of a 120-day period. If a member meets his/her obligations before the 120 days are up they are entitled to receive their Boot patch no earlier than 90 days, provided they meet all other (loyalty and conduct) requirements. A new member must make 3 meetings or events, or a combination thereof, during the 120-day trial period to become a full member. **A \$50.00 patch deposit is required before National will issue the Boot Patch.**

**The Rocker and Eagle Patches.** After a member completes his/her first year (from the day they receive their boot patch) as a member in good standing, they will be issued the Eagle & Rocker patches, **which is the property of National.** **A \$100.00 patch deposit is required before National will issue the Rocker and Eagle Patches.**

## Membership Obligations

**Retrieve Patches:** It is the Chapters responsibility to retrieve all patches. If a member does not renew dues in a reasonable time, thirty days from the end of February the Chapter President or his appointed representative will collect their patches. Any Chapter that does not retrieve the members patches will be held liable for their cost. Any problems from a delinquent member to collect our property, if needed have a lawyer send a letter and take them to court (quote the constitution) that a member will pay all court and lawyers fees. **The Chapter will pay National \$150.00 per set lost and members deposit will not be refunded.**

**If you mail your patches to the Chapter, make sure you send the package CERTIFIED or PRIORITY mail for tracking purposes and insure the package for \$150.00.**

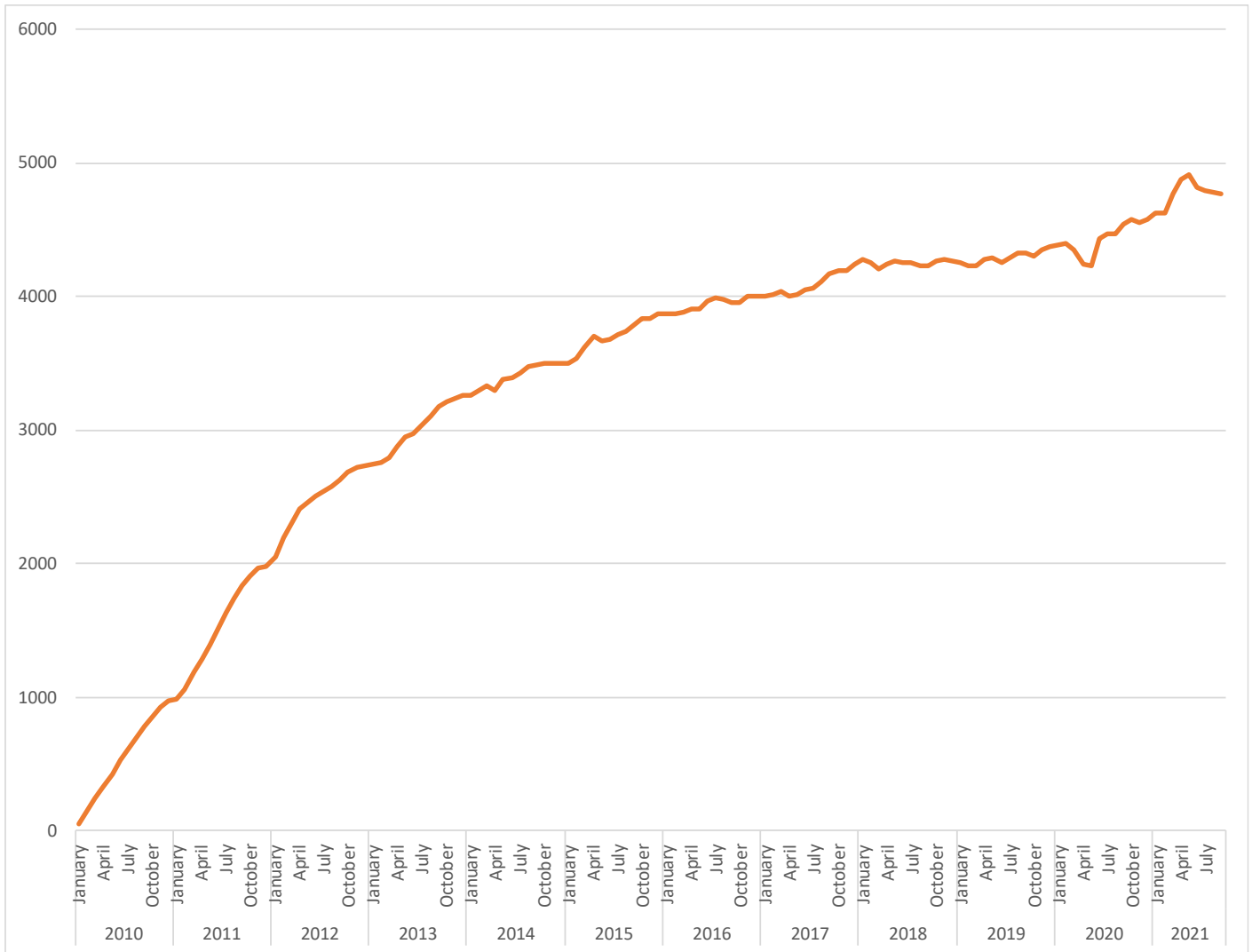

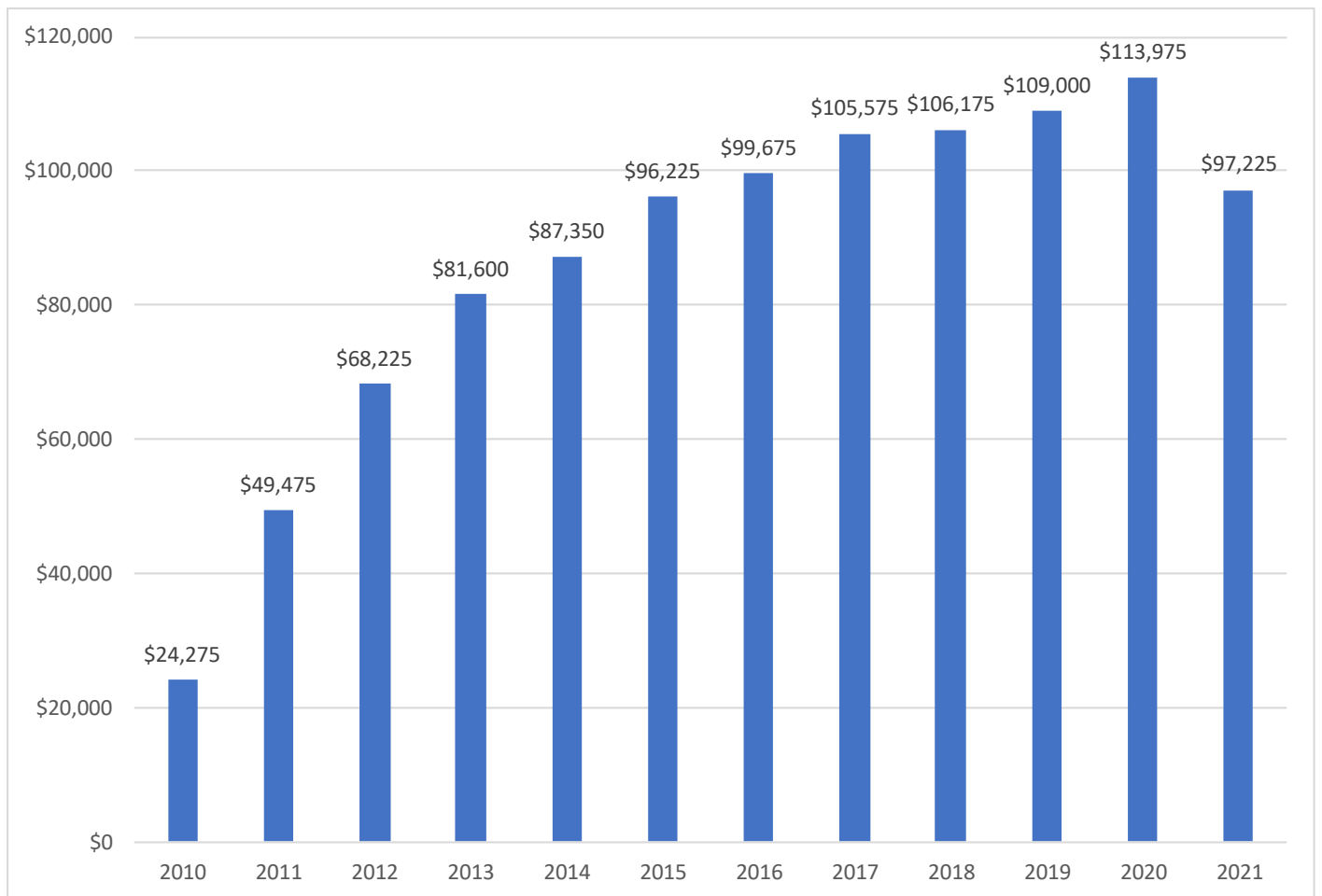
